Most recently, we have been informed of the proposed building of a shooting range in our community. The noise, traffic and shooting range itself will be a huge danger to our families who work, play and live near this building. In addition, the shooting range is only 600 feet from a cemetery and shooting may occur during a funeral. This shooting range will interfere with our property right of quiet enjoyment of our homes and property. It will also adversely affect our animals and our peaceful way of life.
