Greetings Mr. Ramey,

These records are provided in response to your record request. Thank you for your patience. You requested five items and these will be covered in turn. All records were produced by others in the respective Tax Departments and if you feel that any were omitted, please let me know and I will ask them to research any records that you feel were not provided in full.

First you requested a list of the machinery and equipment, with value listed, that forms the basis of your present taxes. In researching this item, Haywood County Assessor records indicate you did not list your personal business property for either Ram Dog Enterprises or Ramey Wrecker Service for several prior years. Therefore, you were sent letters stating that the value of the business property would be estimated. There is no evidence of listing items or filing anything to refute the estimated values. Copies of these letters are provided as the answer to this request.

Next, you requested a list of all attorney fees that you have been charged. A pay history has been provided as part of this request which includes, among other items, attorney fees aid to the County. In addition, if any fees were paid to Mr. Pinkston, who works on tax collection and foreclosure matters for the County, and not listed in the pay history, then our office has requested the copies of the letters to you stating the fees. Once received, they will be forwarded to you.

You requested a review of your accounts to make sure that he is/was not being double charged for items on the list in number one. As stated, the County used estimations of value for the businesses based on the types of business and did not individually list items. If a tax payer wants an individual listing, they are responsible for completing the listing. There are no documents that would answer this request other than the letters mentioned.

You requested an explanation as to why items that you assert were paid under the name of Ram Dog in several years in the mid-2000's are now being requested to be paid under Ramey Wrecker for the same years. After discussions with the Tax Assessor's Department, and in review of the fact that there are no listings of individual business personal property, I cannot find anything to support or deny this assertion or fulfill this request other than the records listed above. I would suggest that you set up a meeting with the Tax Assessor to discuss this.

You have requested a payment history showing his payments in sequence for your accounts. Payment records for your accounts accompany this response.

The attached records are the ones that best satisfy your request.

General Statute 105-277.1 Property Tax Homestead Exclusion For Elderly Or Disabled Persons:

residence that may be excluded from taxation is the greater of twenty-five thousand dollars (\$25,000) or fifty percent (50%) of the appraised value of the residence. Income means all North Carolina excludes from property taxes a portion of the appraised value of a permanent residence owned and occupied by North Carolina residents who are at least 65 years of age or are totally and permanently disabled, and whose income does not exceed twenty-eight thousand one hundred dollars (\$28,100). The amount of the appraised value of the moneys received from every source other than gifts or inheritances received from a spouse, lineal ancestor, or lineal descendant.

If you received this exclusion last year, you do not need to apply again unless you have changed your permanent residence. If you received the exclusion last year but the property no longer qualifies for any reason, please notify the assessor. General Statute 105-277.1 B Property Tax Homestead Circuit Breaker Deferment:

Commonly Asked Questions

Who must file a listing and what do I list?

Any individual(s) or business(es) owning or possessing personal property used or connected with a business or other income producing purpose on January 1. Temporary absence of personal property from the place at which it is normally taxable shall not affect this rule. For example, a lawn tractor used for personal use, to mow the lawn at your home is not listed. However, a lawn tractor used as part of a landscaping business in this county must be listed if the lawn tractor is normally in this county, even if it happens to be in another state or county on

NCGS §105-308 reads ... "any person whose duty it is to list any property who willfully fails or refuses to list the same within the time prescribed by law shall be guilty of a Class 2 mlsdemeanor. The failure to list shall be prima facie evidence that the failure was willful." A Class 2 Misdemeanor is punishable by imprisonment of up to 60 days.

When and where to list?

<u>Listings are due on or before January 31</u>. They must be filed with the County Tax Department. DO NOT FILE THIS FORM WITH THE NORTH CAROLINA DEPARTMENT OF REVENUE. This form will not be accepted by the NC Department of Revenue.

As required by state law, late listings will receive a penalty. An extension of time to list may be obtained by sending a written request showing "good cause" to the County Assessor by January

The total of this account represents investment in tangible personal property, and is to be listed with the other capital assets of the business during the listing period. List in detail. Group (3) Office Furniture & Fixtures

This group is for reporting the costs of all furniture & fixtures and small office machines used in the business operation. This includes, but is not limited to, file cabinets, desks, chairs, adding machines, curtains, blinds, ceiling fans, window air conditioners, telephones, intercom systems, and burglar alarm systems.

Group (4) Computer Equipment

This group is for reporting the costs of non-production computers and peripherals. This includes, but is not limited to, personal computers, midrange or mainframes, as well as the monitors, printers, scanners, magnetic storage devices, cables & other peripherals associated with those computers. This category also includes software that is capitalized and purchased from an unrelated business entity. This <u>does not include</u> high tech equipment such as proprietary computerized point of sale equipment or high tech medical equipment, or computer controlled equipment, or the high-tech computer components that control the equipment. This type of equipment would be included in Group (1) or other.

Group (5) Leasehold Improvements

This group includes real estate improvements to leased property contracted for, installed, and pald for by the lessee which may remain with the real estate, thereby becoming an integral part of the leased fee real estate upon expiration or termination of the current lease, but which are the property of the current lessee who installed it. (Examples are lavatories installed by the lessee in a barbershop, special lighting, or dropped ceiling.) If you have no leasehold improvements write "none". Contact the Haywood County Tax Department to determine if leasehold improvements have already been appraised as real property.

Group (6) Expensed Items

This group is for reporting any assets which would typically be capitalized, but due to the business' capitalization threshold, they have been expensed. Group (7) Supplies


