Subject: 16CRS620, Dewey Gidcumb [R] Indicted by Grand Jury for voting twice.

Dewey Gidcumb [R] was indicted by the Haywood County Grand Jury on July 11, 2016, for voting twice in the March primary this year, a CLASS I Felony (3-12 months prison) , re: **NCGS § 163-275(7)**.

§ 163-275. Certain acts declared felonies.

Any person who shall, in connection with any primary, general or special election held in this State, do any of the acts or things declared in this section to be unlawful, shall be guilty of a Class I felony. It shall be unlawful:

(7) For any person with intent to commit a fraud to register or vote at more than one precinct or more than one time, or to induce another to do so, in the same primary or election, or to vote illegally at any primary or election;

The indictment read:

KNOWINGLY AND WITH FRAUDULENT INTENT VOTE MORE THAN ONE TIME IN THE SAME PRIMARY ELECTION BY PRESENTING HIMSELF AND VOTING IN THE MARCH 15, 2016 FEDERAL, NORTH CAROLINA, AND LOCAL PRIMARY ELECTIONS, AS COMBINED IN ONE BALLOT, WHEN IN FACT DEFENDANT HAD PREVIOUSLY VOTED IN THAT SAME PRIMARY ELECTION ON MARCH 3, 2016, AS AN ABSENTEE VOTER DURING A "ONE-STOP" VOTING OPPORTUNITY AS DEFINED AND DESCRIBED IN N.C. GEN. STAT. 163-227.2.

Bond for Dewey Gidcumb was set at \$5,000. The complete case file for 16CRS620 follows...

I was first alerted to this crime from a discussion at the DA's office. Ah-ha, I indicated, I'll bet it was a democrat. I was told I would be surprised. Not only was Dewey Gidcumb a Republican, he was actually on the HCGOP Executive Committee during the reign of Pat Carr. Look for a Grand Jury Indictment, I was told.

Hmmmmmm.

If Dewey Gidcumb voted absentee at a "One-Stop" opportunity on March 3, why did not the local Board of Elections, that would be Robert Inman [D], examine all of the absentee "One-Stop" votes and put those into his system, so that when people showed up on voting day to cast their ballot, those that voted prior to voting day would be blocked out and prevented from being validated and getting one of those little forms you get to sign after you register at the precinct?

It appears that this individual was caught after-the-fact at some point by Robert Inman's [D] alert voting staff. I have to wonder, was it only Republicans that received this scrutiny?
