**Subject:** HCGOP Special Called Meeting Summary, Roll Call that voted FOR Party Disloyalty Resolution.

During an unannounced Closed Session of the Special Called Meeting of HCGOP on 5/23/2017, CHARLES DOUGLAS WRIGHT read a Resolution accusing five people of Party Disloyalty.

You remember CHARLES DOUGLAS WRIGHT, don't you?

The resolution was to accuse prior HCGOP and two current HCGOP members of Party Disloyalty. CHARLES DOUGLAS WRIGHT fumbled his way through reading the resolution, skipped part of it, and had to be reminded to read the entire resolution by Ted Carr.

The accused were:

1. Eddie Cabe
2. Jeremy Davis
3. Richard West
4. Paul Yeager
5. Myself.

CHARLES DOUGLAS WRIGHT indicated that there were attachments and affidavits to go along with the Resolution, but none were forthcoming during the meeting. CHARLES DOUGLAS WRIGHT indicated that this resolution had the blessing of NCGOP General Counsel. There were no copies of the Resolution that were distributed.

How did people at the meeting know what they were voting on? There were no specifics regarding the alleged offenses of these people. It would appear that all of these voting members had prior knowledge of this rigged meeting before the meeting even started.

The motion was voted on, and passed by a vote of 12 to 2 (Jonnie Cure and I voting no).

There are four Officers, the Chair does not vote unless there is a tie.

The first column is the precinct.

The second column are the Precinct Chairs

The third column are the Vice Precinct Chairs. They do not vote unless a Precinct Chair is not present.

The people with red dots in front of their names were present at this meeting on 5/23/2017.

Barbara Buck and Al Goodis did not remain for the Closed Session.

Note that both Ted Carr and Denny King voted and had their votes counted, even though they were Vice Chairs. Rumblings are that there were precinct reorganization meetings which made them Precinct Chairs so that Kebbie (Ken & Debbie) could get a couple of extra votes.

It has been Debbie's practice in the past to make frantic telephone calls to everyone she wants to vote with her to attend meetings, and it looks like she and some of her minions insured that there was a quorum at this meeting.

It's not clear to me that this whole Party Disloyalty thing could really back-fire on them.

Debbie's calling her following for this meeting reminds me of the fabled tale of the Pied Piper of Hamelin, (German: Rattenfänger von Hameln, also known as the Pan Piper, the Rat-Catcher of Hamelin). He is the title character of a legend from the town of Hamelin (Hameln), Lower Saxony, Germany. The legend dates back to the Middle Ages, the earliest references describing a piper, dressed in multicolored ("pied") clothing, who was a rat-catcher hired by the town to lure rats away with his magic pipe. He led the rats to a cliff and all the rats followed the Pied Piper over the cliff and met their demise.

There were people I had never seen before at any prior HCGOP meeting. One interesting character was from the Crabtree Precinct. His name is William Kellas, a Precinct Chair. He uses a walker, and has obvious difficulty moving about. I had seen him at prior Precinct Meetings with Donna Forga, (that's Haywood County District Court Judge Donna Forga), but he was always accompanied by someone. Not this time. It looked like he was making an extreme personal effort to make this meeting.

Upon verification of his address on the Haywood County Voter Registration List,

we see that both Donna Forga and William Kellas reside at the same address, 961 Silvers Cove Road, in Clyde.

Well, isn't this cozy. William Kellas listened to the Resolution read by CHARLES DOUGLAS WRIGHT, and blindly voted "aye" to pass the resolution with absolutely no details what-so-ever regarding what any of these people did to deserve being accused of Party Disloyalty.

Interestingly enough, all of the people present at this meeting were called as witnesses to the hearing presided over by Donna Forga on 2/7/2017, Case Number 16CR053432, CHARLES DOUGLAS WRIGHT 1M-Communicating Threats. The witnesses (other than myself and CHARLES DOUGLAS WRIGHT) were:

(Two of the folks accused of Party Disloyalty, testifying on my behalf)

- Eddie Cabe
- Richard West

(Pal's of Ken Henson's, testifying on behalf of CHARLES DOUGLAS WRIGHT)

- Lynda Bennett
- Cornelia Cree
- Ken Henson himself.

I personally know that I will never be able to trust Ken Henson again in my life after he lied his [Expletive Deleted] off when he was called to testify in 16CR053432, CHARLES DOUGLAS WRIGHT, 1M-COMMUNICATING THREATS against me when CHARLES DOUGLAS WRIGHT shouted "BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS". CHARLES DOUGLAS WRIGHT was defended by Ken Henson's son-in-law, Zeb Smathers, and after Judge DONNA FAY FORGA [R] refused to recuse herself, dismissed the charges. Testimony from both Lynda Bennett and Cornelia Cree followed Ken Henson's. All never heard CHARLES DOUGLAS WRIGHT ever say "BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS".

Zeb Smathers [D], the lawyer who defended CHARLES DOUGLAS WRIGHT, by the way, is Ken Henson's son-in-law.

Why would/should Donna Forga have been wise to recuse herself from this case?

I submitted the following Affidavit, placed it in Case File 16CR053432, and when ADA Kate Wrenn, prosecutor requested that Forga recuse herself, Forga read the Affidavit and said, in essence, "I don't have a problem judging this case, all this shows is that Monroe Miller does not like me".

**Monroe A. Miller Jr.**, being first duly sworn deposes and says:

1. I am a Haywood County Taxpayer, and have lived in Haywood County since 2004.
2. That DONNA FAY FORGA is scheduled to hear my case on Tuesday, February 7, 2017, 16CR053432 in District Court, re: CHARLES DOUGLAS WRIGHT Communicating Threats.
3. That DONNA FAY FORGA sat as Vice-Chair on the Haywood County Board of Trustees during the period of time that the Board of Trustees was preparing to go before the Haywood County Commissioners for financing of the Creative Arts Building.
4. That Rose Johnson was President of Haywood Community College at that time, and Mark Bumgarner was Chair of the Haywood Community College Board of Trustees.
5. Prior to the presentation to County Commissioners, the Board of Trustees voted unanimously to approve the building plans for the Creative Arts Building. However, the Board of Trustees was split nearly 50/50 about approval of the FLS Solar Thermal portion of the project.
6. During the Public Comment Session at the Haywood County Commission Meeting on September 7, 2010, I made a Public Comment [re: Haywood County Commissioners Minutes, Regular Meeting, 9/7/2010]. From the minutes of that meeting:  
  
“Monroe Miller stated that Dr. Rose Johnson, President of HCC, failed to provide the HCC Board of Trustees the FLS contract and refuses to answer his questions regarding the proposed Creative Arts Building. Mr. Miller summarized the decisions made at the HCC Board of Trustees meetings held August 30<sup>th</sup> and September 2<sup>nd</sup>, 2010. Mr. Miller urged the Board to table this motion for 90-120 days until the HCC Board of Trustees makes its final decision regarding the FLS Solar portion of the final contract.”
7. Once I alerted Rebecca Morgan, Secretary to the Board of Commissioners at that time, that there were irregularities that occurred during the September 7, 2010 meeting, the entire context of the meeting regarding the HCC contract was entered as a Verbatim Transcript into the minutes.

8. I had alerted several county commissioners prior to the September 7<sup>th</sup> 2010 meeting that there was a split vote with the FLS Solar portion of the contract.
9. Chairman Kirkpatrick, during the meeting, asked the following of Mark Bumgarner, who was standing shoulder with Rose Johnson and DONNA FAY FORGA,  
  
“... I guess where I come down is, is if you had come in here today and I want to ask you this again to make sure, but if you’d come in today and there was a still a 6 / 5 decision I probably would be in line with Kevin right now because I would feel uncomfortable with the board coming in that you don’t have a real good consensus, but you’re telling me, Mark, that you all voted on it, or you had the approval. I don’t know if there was a vote or not, but you, you looking at me now have the approval of everyone on your board to move forward with this project.”
10. Mark Bumgarner responded, standing shoulder to shoulder with Rose Johnson and DONNA FEY FORGA, that:  
  
“Yes, Sir. We’ve had eleven board members and that all unanimously agreed that, on the construction costs and the budget request, loan request amount, 100%.”
11. DONNA FAY FORGA failed by omission, to correct Mark Bumgarner, that the board did not unanimously agreement on the FLS Solar portion of the contract.
12. I wrote the following in my Haywood County “Toeprints”, September 9<sup>th</sup> 2010, Vol.#1 Issue #3, the following:  
  
“It appears to me that there might have been a slight bit of deception on the part of **Bumgarner, Donna Forga** (who is running for District Judge in Nov.) and **Rose Johnson** (who all stood at the podium) in misleading the commissioners to believe the Board of Trustees “... were unanimous”. [Perhaps **Bumgarner** and **Forga** might consider stepping aside from their current positions as Chair and Vice-Chair, respectively, on the Board of Trustees at this time]. It is now left up to the discretion of the HCC Board of Trustees to determine if the Solar Thermal portion of this project will be approved - **not** the county commissioners any more.”
13. In a subsequent meeting with DONNA FAY FORGA, in a parking lot of a restaurant in Maggie Valley at a Republican political gathering, I confronted DONNA FAY FORGA on her Integrity, where DONNA FAY FORGA was reduced to tears.
14. DONNA FAY FORGA has no standing to sit before me in any court hearing to make any judgement on me at all, and must recuse herself from this case. Her best course of action would be to grant a continuance before another Judge, excluding Kristina Earwood.

I swear under pains and penalties of perjury that the above is true and accurate.

This document is hereby recorded pursuant to Rules of Federal Evidence, 901 and 902. The preceding items of evidence are self-authenticating or identifying evidence; they require no extrinsic evidence of authenticity in order to be admitted.
