GENERAL ALLEGATIONS

1. That the Plaintiff is a resident of the State of North Carolina and Haywood County and was at the time of the matters herein complained of and is at the time of this Complaint a resident of said County and State.
2. That Richard Owen West is a resident of Haywood County Haywood County, State of North Carolina and was at the time of the matters herein complained of, and is at the time of the filing of this Complaint, a resident of said County and State.
3. That Jeremy Davis is a resident of Haywood County, State of North Carolina and was at the time of the matters herein complained of, and is at the time of the filing of this Complaint, a resident of said County and State.
4. That Eddie Cabe is a resident of Haywood County, State of North Carolina and was at the time of the matters herein complained of, and is at the time of the filing of this Complaint, a resident of said County and State.
5. That John Doe's 1 through 6, upon information and belief are residents of Haywood County, State of North Carolina and are unknown at the time of the filing of this action but upon information and belief the Plaintiff believes that they are members of the Haywood Republican Alliance and are responsible for the actions hereinafter complained of.

6. That the Haywood Republican Alliance (hereinafter referred to as "Alliance") upon information and belief is a registered Political Action Committee with the State of North Carolina and are existing under and by virtue of the election statutes of said State and are entitled to sue and be sued. See Exhibit "A" attached hereto and made a part hereof.

COUNT 1
INVASION OF PRIVACY BY APPROPRIATION OF NAME OR LIKENESS

7. Now comes the Plaintiff and re-adopts and re-pleads paragraph numbers 1-6 above as if fully set out herein.
8. That upon information and belief, Defendant Richard Owen West is the Treasurer of the Defendant Alliance. See Exhibit "A" attached hereto and made a part hereof.
9. That upon information and belief Defendants Jeremy Davis and Eddie Cabe are members of the Defendant Alliance. See Exhibit "B" attached hereto and made a part hereof.
10. That on or about late Spring or early Summer of 2017, the herein named Defendants along with the members of the Haywood Republican Alliance began disseminating photographs with the likeness of the Plaintiff placed on emails and a video depicting the Plaintiff in various poses, positions and disseminated such photographs throughout the internet and had the images placed on campaign style buttons which were offered for sale in the commerce of Haywood County and other places to include but not limited to political rallies, social events, fairs and entertainment events by way of establishing booths and offering the same for sale to the public.
11. Upon information and belief the Defendants named herein and each Defendant participated in the sale and dissemination of the Plaintiff's likeness without consent, permission or authority of the Plaintiff. See Exhibits "C-1", "C-2", "C3" and "C-4" attached hereto and made a part hereof.
12. In addition, the Defendants herein above named as well as the individuals known and unknown, distributed upon the internet certain pictures of the Plaintiff as well, with musical overlay dubbed over the photographs or likeness of the Plaintiff with a Sonny and Cher song, "I Got You Babe" and "Barbie Girl." See Exhibit "B", D-1," "D-2," "D-3" and "D-4" attached hereto and made a part hereof.
13. That upon information and belief such dissemination of the Plaintiff's likeness was a part of a commercial enterprise through advertisements and other means which created a commercial benefit to the named Defendants. See Exhibits C-2, C-3 and C-4 attached hereto and made a part hereof.

14. As a result of the commercial use and benefit of the Plaintiff's likeness the Defendants and each of them generated sources of income for the benefit of Defendant Alliance.
15. That the Plaintiff's name and likeness was never authorized for use by her for the benefit of the Defendant Alliance or use by each of the named individuals.
16. That as a result of these wrongful tortious acts, the Plaintiff has been damaged in her reputation, her prestige, her social standing and has suffered embarrassment and humiliation amongst the community and amongst her peers, friends and acquaintances.
17. That the Defendants, and each of them, among others, have publicly humiliated, cajoled, smeared, made fun of and created an atmosphere of humiliation and character assassination against the Plaintiff. See Exhibit "E-1," "E-2", and "F" attached hereto and made a part hereof.
18. That all the acts herein complained of was done intentionally by the Defendants and other John Does all to cause harm and embarrassment to the Plaintiff.
19. That the Defendants by receiving monies for the commercial exploitations of the Plaintiff's image has received sums from the sale of the Plaintiff's likeness and name in an unknown amount which will be established at the time of the trial of this action.

PUNITIVE DAMAGES

20. Plaintiff re-pleads and re-adopts paragraphs 1-19 above as if fully set out herein.
21. That the conduct herein complained of was done intentionally, spitefully, with the specific intent to harm the Plaintiff and her reputation within the community, was done with spiteful purpose and the intent to cause ridicule and embarrassment to the Plaintiff. See Exhibit "G" attached hereto and made a part hereof.
22. That the conduct herein complained of was reprehensible and done with an intentional spiteful purpose, done with the intent to embarrass, humiliate and ridicule the Plaintiff, and that this conduct extended over several months and that the Defendants and each of them profited by such conduct.
23. That at all times herein complained of the Defendants knew of the consequences of their actions which will be shown from the email chains that will be presented at the time of the trial of this action.

INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS

24. The Plaintiff re-adopts and re-pleads paragraphs 1-23 above as if fully set out herein.
25. That the wrongful conduct herein complained of by the Defendants and each of them has caused the Plaintiff to suffer emotional psychological distress, embarrassment, humiliation, physical disability, loss of appetite, stress and other complaints which will be shown at the time of the trial.

INJUNCTIVE RELIEF

26. The Plaintiff re-adopts and re-pleads paragraphs 1-25 above as if fully set out herein.
27. That the dissemination of the likeness and the character of the Plaintiff as established herein has been done without the consent or permission of the Plaintiff, has been done with an ill will and intentional purpose to disseminate the Plaintiff's likeness throughout the Haywood County community and throughout the State of North Carolina without consent by the Plaintiff and constitutes an invasion of privacy and was done without permission.
28. That the Plaintiff has a likelihood of success in this action for invasion of privacy for commercial gain and the Plaintiff has no other means of stopping such dissemination pending the trial of this matter except to seek an injunctive relief both ex parte, preliminary and permanent in order to stop the Defendants wrongful conduct.
29. That the Plaintiff has no adequate remedy at law to prohibit the continued dissemination of her likeness without the Court's intervention granting the Injunctive relief herein sought.
30. That the Verification attached hereto shall be treated as an Affidavit in support of this relief sought for a temporary restraining order, preliminary and permanent injunction.

WHEREFORE, having fully prayed the Plaintiff seeks of the Defendants jointly and severely,


1. The sum in excess of \$25,000.00 for the appropriation of her name or likeness without her consent.
2. That the Plaintiff have and recover punitive damages in the sum in excess of \$25, 000.00 for the intentional and wrongful acts of each Defendant.
3. The sum in excess of \$25,000.00 for intentional infliction of emotional distress.
4. For temporary, preliminary and permanent Injunctive Relief, ordering that the Defendants and each of them to cease and desist from the publication, sale, distribution or use of the Plaintiff's likeness.
5. The cost of this action, including reasonable attorney's fees, be taxed to the Defendants.

6. For a trial by jury.

7. For such other and further relief that the Court deems just and proper.

What is happening here does not come across as informing about tyrannical actions or attempting to seek justice over those matters - it appears rather to be a personal vengeance. I have not seen Debbie during all of this do one single thing to defend herself or fire back in the same ways. If it were me, I would have a hard time being so gracious. I hope that those reading this will take what I say with a sincere heart for consideration.
