I understand that a question arose during the Kangaroo Court ExCom meeting Saturday whether or not KEVIN ENSLEY was censured by HCGOP. 



An example is "Ch., Jonie Cure WW", however in this example, she spelled Jonnie's name wrong and has her associated with the wrong precinct. Going down further, under Guests:, I am listed as "Ch. Monroe Miller AC". That means I had been logged in and recognized as Precinct Chair for Allens Creek.

Ken Henson pulled me outside before the meeting started, saying we had to talk. He told me that people were not coming to the meeting because I had said I was going to be there. He said it is the prerogative (Ken did not actually use that big word) of the Chair to throw out anyone he chose. So instead of having the Executive Committee throw me out of this meeting as they did on November 6, he alone was going to throw me out. I told him he had to call the meeting to order first. I also said to him, among other things, that he never sent me any written notice that the Executive Committee removed me as Allens Creek Precinct Chair. Upon reflection, it appears they never did. § 14-196.3 is the NC General Statute on Cyberstalking, one that I am well familiar with as SAVANNAH SIMONE TEDESCO's case against me was dismissed. You won't find anyone more careful about what goes

into an e-mail than me.

Dallas ordering me to CEASE AND DESIST would have more weight if it were coming from you. Why don't you send me a letter to CEASE AND DESIST, and I will also attach that to my next grievance against you with the NC Bar Association.



- North Carolina Republican Party State Headquarters located at 1506 Hillsborough Street, Raleigh, North Carolina 27506; and/or
- The 2018 North Carolina Republican State Party Convention, State Central Committee, and State Executive Committee Meetings.

Your various computer postings, disparaging the leadership of the Haywood County Republican Party and the North Carolina Republican Party, appear to constitute *libel per se*. You have been barred from holding office in the Party. In addition, please note that your discourse with the Executive Director of the Party constitutes harassment. The Party has determined, based on the foregoing and other actions that are not expressly enumerated, that you should not attend the convention or appear at the other locations indicated.
