I plotted several area's of interest in a series of graphs (using my very expensive green graph paper). They are:


- Debt / Long Term Liabilities
- Haywood County Debt (2005 2017)
- Pensions (LEO, OPEB, LGERS)
- Fund Balance
- · Tax Rate
- Solid Waste Fund (a practically useless graph, due to almost no detail, thanks to David Francis)
- Capital Project Fund Solid Waste / Landfill Fund (Another practically useless graph, due to almost no detail, thanks to **David Francis**)

All of these graphs utilize data from CAFR's.


I get to make comments on each of the following graphs.



This shows debt information from 2009. Debt spiked in 2011, and has been steadily been beat down. However, the End Balance has taken a departure the last two years and is increasing. Why (we shall see in following graphs)?




This graphs goes back further in time, when our debt was less than \$35M.



This is a graph of pensions for County Employees. OPEB is steadily increasing without bounds.

But wait! What is LGERS? It shot up from 1.5M in 2016 to 7.3M last year. WTF? It appears that this is a factor in the first graph of Debt / Long Term Liabilities.


I don't know about you, but I haven't heard anything about this program, except for what I read in the CAFR.



This is a plot of Fund Balance. It has steadily grown over the past several years.

The graph is marked with green upward arrows, and these indicate Property Tax Increases supported by our county commissioners.


This is a plot of the steadily increasing Property Tax Rate. There is an election coming up in November. An election issue should be to lower the tax rate in stead of increasing it.
