Guess what **Bryant Morehead's** response was?

**“At this time I am unable to locate an executed document signed by Mr. Teague and Ms. Viau. Additionally, I do not have any other insurance documents other than the one you reference below.”**

There is no MOU, and no evidence of any Certificate of Liability Insurance (three pages of incomplete chopped-off pages of a policy, and nothing after that).
