I copied the text, and here it is...

*"Mike Drogo I reached out to Lynda Bennett on her page about this and this was her response; "the recording was from a Party work session where we had drafted palm cards for the 2016 elections. This is a fabrication. The only thing that was accurate was that this happened in 2016. There were never any palm cards or ballots presented at the meeting. Bennett was the one screeching I'm a never Trumper at the 1 minute -19 second (1:19) point on the second recording, right after CHARLES DOUGLAS WRIGHT had just threatened me. At (2:20) on the recording, Bennett says: ""Trump" says all kinds of weird things. I don't know what he is going to say next". No one was furious she had printed Trump on the ballot, which were not produced at the meeting. It was an organizational meeting. Bennett had supported Ted Cruz, and held signs promoting Cruz, not Trump, at least up to that point. Then, she calls one of her opponents, Jim Davis, a RINO!

As I said to you before, I will never in my life believe anything that comes out of this woman's mouth again.

Give me a reason, and I will splash these two recordings all over my website.
