Slides from Bryant Morehead's Budget Overview presented on 5/3/2021, Slides from Bryant Morehead's Recommended Budget presented on 5/17/2021, and Documentation I received from Julie Davis on 5/16/2011 regarding her calculation of Revenue Neutral Tax Rate. Contained in Julie Davis' documentation (second page) is a 2010 County Certification sent to the NCDOR.

I would like a copy of the County Certification to NCDOR for our current time period, irregardless of who sent it, i.e., you, Bryant Morehead, whoever.
