## Mr. Gannon,

I don't see any reference which backs up your statement as to why "the State Board does not permit members of the public to disassemble or otherwise manipulate certified voting equipment".� All you sent me was 08 NCAC 04.0306, which addresses voting systems at the county level, not the State Board level.

08 NCAC 04 .0306DUTIES OF CUSTODIANS OFVOTING SYSTEMS(a) The chair of the county board of elections shall be responsible for the safekeeping, storage, maintenance and care of the voting system. The voting system shall be stored in a location such that access is restricted to county board of elections staff and the system cannot be tampered with when not in use on election day. The county board of elections may appoint as many persons as determined necessary for the maintenance, storage and care of the voting system and for the preparation and testing of the voting system and delivery to the voting precincts preceding a primary or an election. Persons employed for this purpose shall be compensated for their services as authorized by the county board of elections.(b) On election day when the system is used for voting purposes and until the chair of the county board collects the system, the voting system shall be under the supervision and control of the chief judge unless the county board of elections authorizes another elections official to have supervision and control. History Note: Authority G.S. 163-23; 163-165.7; Temporary Adoption Eff. April 15, 2002; Eff. August 1, 2004; Readopted Eff. June 1, 2019

#### Mr. Gannon,

Thank you for your response yesterday. I gleaned some new information from my multiple Requests for Public Information, which were interesting, but not too informative.

(Addressed to Karen Bell) Did you know prior to the article cited in Mr. Delancy's post if you even knew that ES&S had designed as part of the DS200 line of products secret modem capability? Her response, presumably filtered through you was: "And yes, we knew that some versions of DS200 machines had modem capabilities." Well, how long before Mr. Delancy's post did she know about it?

The second item of interest was your voluntarily providing the procedure of what happens when I insert my ballot into a tabulator. You indicated: "For now, here's a basic description of what happens when you insert your ballot into a tabulator:

Election results data are generated in the ballot tabulators at each voting location in every county during early voting and on Election Day. When a voter casts a ballot in a tabulator, that voter's selections are recorded on a media card in the tabulator. These cards, which come from certified, tested and secured voting equipment overseen by bipartisan election officials, are securely delivered with proper chain of custody to the county board of elections office. There, the results are loaded into the voting system election management software, which is not connected to the internet, to aggregate county results. The county files are then loaded onto a new, unused flash drive for upload to the state Election Reporting System (ERS), where they are made available to the public on the State Board's website here: NC SBE Contest Results.

Official election results are verified by the State Board of Elections at state canvass after a series of post-election audits and, if necessary, recounts."

Well, this was part of my original Request for Public Information to Robert Inman here in Haywood County. There are 100 Counties in North Carolina, with each county operating an autonomous Board of Elections, directed by appointed Board of Directors members. I wanted to hear what they actually did, not what the State Board, you, told them what should have been done. I wanted to hear that directly from them, to see if things matched - you know.

When I made a Public Comment before the Haywood County Board of Elections, requesting detailed information as to how my vote eventually wound up at the NCSBE, I was advised by Danny Davis that they would seek guidance from you, NCSBE, Review the audio recording I made of that meeting. <u>.MP3 audio recording.</u> Board of Elections Board meeting. My Public Comment. 4/13/2021...

Now, you appear to be telling me it is up to the local board to make the determination. This is going round-and-round, a Catch-22, where no one appears to be taking any responsibility - not you (NCSBE) or Danny Davis. I still can't get Robert Inman to send me simple copies of Board meeting minutes relating to discussions regarding ES&S, a matter which should appear on the agenda of their June Board of Directors meeting. Robert Inman appears to be running his own little banana republic, indicating to me he can't release minutes until they are signed by all board members, not approved at any subsequent board meeting. He is squealing like a pig, where all he has to do is reach into his Board Meeting notebook (or computer) scan and send me the documents.

Thank you for sending me all of the information links, but as far as I could tell, there were no NCGS, Title code, NCSBE board minutes or anything else prohibiting taking a look inside these DS200 voting machines. There were mostly Press Releases, presumably generated by you.

I would think you all would want this to go away. The best way to do this is to let's all get together, pop one of these machines open, and call it a day. Someone from ES&S can re-certify the machine after we are done.
