It would appear that you sent me copies of documents that had found their way into one of your agenda packets, with the recognizable page numbers in marker in the upper right corner of the documents (Pages 22-25).

So, this is what I get so far ---

The application was made by Neal Ross on 10/4/2018, at a business address of 390 Freemont Road, a residence.

The application was approved by Chris Lee on 10/15/2018, 11 days!

Ross sold the property to Wishart on 10/16/2018, CF and D. Check the right of ways. See deed attached. 1 day!

Wishart sold two lots at the entrance on 12/10/2019 and 7/15/2020. Check the right of ways. See deeds attached.

So when NCDOT gave the approval on 10/15/2018, Chris Lee thought Neal Ross was the developer instead of Wishart???

What do you make of this? Maybe Kirkpatrick can unravel this.

Upon further observation of the document you sent to me, NCDOT Permit10_15_18.pdf, I think we all know that Neal Ross was not the developer, rather it is Greg Wishart, but Neal Ross signed the application as the owner of the property. This seems like border line fraud to me, but let's continue. Well, Neal Ross did own the property on the date that Chris Lee approved the permit (sold it a day later with the aid of James Weaver "Kirk" Kirkpatrick the III), but the drawing included with the application and approval shows Neal Ross's property being split into two parcels, and doesn't mention Neal Ross anyplace. How do you explain this?

Unfortunately, I cannot read the book and page numbers along with the date of the drawing on the low resolution drawing that you supplied, so can you dig deep and find a higher resolution drawing for me? I have a parallel request into NCDOT for this document, but got the following message:

Please note that the operative phrase here is: "There is no new information to share until we receive an application from the Developer.". This STREET AND DRIVEWAY ACCESS PERMIT APPLICATION is supposed to be filled out by the developer, not Neal K. Ross.

Additionally, I have a copy of Wishart's correspondence to you (with a header "apps ncdot.gov) asking you who to contact about the permitting and approval process.
