Compilation of Survey's and Deeds - Deaver Right Of Way, <u>Allens Creek Road. 9/15/2021...</u>, page 4, where I was taking notes with my meeting with Chris Lee (and a guy named Woodard), that Lee told me that it would take "30 days to render a result from DOT". Well, someone must have gotten some special treatment, because Chris Lee approved the permit on 10/15/2018, only Eleven (11) Days after the permit was submitted! I guess Chris Lee should be commended for expediting this approval.

I hear that you are involved with a new development along Sunnyside Road. Is Kirkpatrick pulling the strings on this one also? If I were you, I would do a little more research that you did at the Lake Buchanan Development.


