The grant was denied by Dogwood Health Trust.

The document entitled "DOGWOOD HEALTH FOUNDATION IMMEDIATE NEEDS GRANT" contains fowl and derogatory comments about the citizens of the Town of Waynesville. No one has confessed as to being the author of this document, although it has all the characteristics of **Bill Cannon**, previous Town Attorney (now replaced by Martha Sharpe Bradley who worked for **Bill Cannon** for over three years), who was unceremoniously fired by the Town of Waynesville because he torpedoed his career by shooting himself in the foot by posting hateful political tweets on social media.

Subsequently, I visited with Jesse Fowler later in the afternoon, and he indicated he had a meeting with you on how to respond to this request. He informed me that:

- He had been hired by the Town about a year ago.
- The City of Waynesville never applied to Dogwood Health Trust for a grant for Amy Murphy-Nugen! Consequently, they have never received funds from Dogwood.
- Amy signed a contract with the city over a year ago, to be paid when she submits an invoice. Money to pay her will most likely come from the General Fund, i.e. Waynesville taxpayers. She has not submitted any invoice yet.
- He expected to get me a copy of her contract late today or early next week.

Jesse Fowler was hired on 10/21/2020. [re: the Mountaineer,

Alderman Chuck Dickson reminded the Board that a grant had been written to the Dogwood Health Trust for the purpose of hiring a facilitator for the Task Force. He said that in that grant there were 4 items listed as the goals and objectives of the committee. He added that the grant would need to be spent in this calendar year.

- > Research the demographics of the Homeless and the causes of homelessness
- > Examine stigmatization, criminalization and discrimination associated with homelessness
- To conduct a gap analysis to identify existing community capacity and additional resources necessary to prevent temporary and chronic homelessness.
- > Develop a collaborative community action plan to fill system gaps and improve existing programs

Mayor Caldwell asked if anyone in the audience if they wished to speak.

Ms. Amy Murphy-Nugen – Western Carolina University professor

Ms. Nugen thanked the Board for opening the process of looking for solutions to homelessness in the community. She said she would like to work with the Task Force in any capacity, and because of her work at Western Carolina University, she feels she could be a facilitator and bring people together who have common goals and different perspectives on how to reach those goals. She stated she had 20 years of experience in affordable housing, community economic development, and addressing social determinants of health issues like homelessness.

• Dr. Amy Murphy-Nugen

Dr. Amy Murphy-Nugen was selected to be the consultant for the Task Force on Homelessness when it was first formed. She has drafted two proposals to fund the activities of the Taskforce on Homelessness. Option A in the amount of \$53,487.50 and Option B in the amount of \$32,287.50. The major difference between the proposals is the time budgeted for community interaction.

Dr. Murphy-Nugen's hourly rate is proposed to be \$100 per hour, with \$4,487.50 budgeted for travel and supplies. Dr. Murphy-Nugen outlined her proposals in the information in the packet.

Manager Hites said that if either option is selected, a budget amendment will need to be completed. Two sample budget amendments have been prepared for the Board's consideration.

A motion was made by Alderman Jon Feichter, seconded by Alderman Anthony Sutton to approve the contract with Dr. Murphy-Nugen and funding proposal option A.

A motion was made by Alderman Anthony Sutton, seconded by Alderman Chuck Dickson to approve Ordinance O-10-20 in the amount of \$53,500.

The motion carried unanimously.

DOGWOOD HEALTH FOUNDATION IMMEDIATE NEEDS GRANT

Description of Current Need/Project:

The Waynesville Community provides two shelters for the homeless. Each offers two meals per day, shower facilities and a total of 90 beds. The legal community treats many of the symptoms of homelessness such as substance abuse and mental health issues as diseases and does not seek to incarcerate individuals unless they have committed a violent crime.

Waynesville's compassionate approach to dealing with homeless individuals has created a destination for both regional and interstate homeless population that far exceeds the Community's ability to house and feed them. The shelters do not permit drug use or violent behavior so many homeless individuals find themselves on the street with no money, no place to stay and nothing to eat. They resort to shoplifting and petty theft for food, tents and money. The businesses that reside between the two shelters are constantly victimized by homeless individuals that have been refused service by the shelters.

The result of these behaviors is a community that is divided into two camps, the group that views the homeless as a group of society's victims in need of support and the group that views the homeless as petty thieves that shoot up drugs and threaten the Town's citizens.

At this juncture the Town needs to develop a process that will brings both groups together to develop a strategy to handle the influx of homeless individuals. No one in the community that has the training and experience to lead the discussion, provide their expertise and help develop a community wide strategy that includes all stakeholders. We believe that a grant from the Dogwood Health Foundation would provide the funds to engage such an expert. The Town would match the Foundation's grant dollar for dollar in order to provide \$50,000 to attract a qualified consultant.

Does your organization serve diverse communities? If So, which ones.

Waynesville is unlike many southern municipalities in that it has a racial breakdown of 92% White, 4.4% Hispanic and 2.7% Black. The Town's most telling diversity is that of income. Waynesville is made up of a wealthy, retired group that reside along the mountain ridges, a group that own businesses and a group that is under employed residing in substandard dwellings and prone to substance abuse. The Town had a thriving industrial sector in Hazelwood into the sixties. Like many other rural communities every industry but two has closed. The Town's median household income is \$34,602 and per capita income is \$25,072. Many of retired mill workers have very little retirement income and their children cannot find jobs that pay a living wage. Another element of income disparity is Waynesville's housing shortage. Affordable housing is being purchased by part time owners and Air BNB speculators. The lack of well-paying jobs, affordable housing and the proliferation of cheap drugs is forcing many people to drug addiction and homelessness. As the numbers of homeless increase, the business owners are demanding that the Town keep them away from the Town's retail areas. The friction between the retail and tourist-based businesses and homeless community increased to the point that the issue became the leading political issue in November's local election. The challenge facing the Town is to develop a line of communication between the wealthy, business and homeless residents. The process would serve to bridge the economic diversity in the Waynesville Community. The reason for our request is to engage an individual with the experience and skill base to bring these competing economic groups together to develop a community strategy to combat the income gap within the Waynesville community.

How does your organization embrace diversity?

Waynesville is unique among NC Towns. It has a history of accepting newcomers with different political views and personal lifestyles. Its residents vary from wealthy retirees from Florida to "Sovern Citizens" who don't recognize the legitimacy of the US government. It is a challenge to provide a customer focused,

small town, level of service to citizens that are angry that we are not a carbon copy of Palm Beach or that citizens must obey State and local laws. The Town provides one of the largest recreation programs in western NC. It prices its recreational amenities so that citizens at all income levels may participate. The Town runs a summer camp program that provides affordable summer recreation programs to help families with summer day care. It provides financial support to numerous nonprofits that provide a range of services to Haywood County residents. Waynesville supports REACH, a domestic violence organization, the Open Door, an organization that feeds and shelters the homeless citizens of Waynesville, the Pigeon Street Community Center that provides services to the neighborhoods where many of Waynesville's Black and Hispanic residents reside and Mountain Projects which provides affordable housing and other social services to lower income residents of our community. The Town Board reflects the diverse nature of our community. It's five-member board is comprised of both Republicans and Democrats, an openly gay member and a female Mayor Pro Tempore. The Town Board is extremely sensitive to the needs of all racial and income classes within the Town.

Tell us what equity means to your organization and how it influences the work of your organization?

It's the policy of the Town of Waynesville to treat everyone with dignity and compassion regardless of income, race or social status. Our Police purchase food for elderly folks when they answer a call and realize that the couple cannot afford groceries. As we move through the workday our employees are alert to social conditions in the community and frequently contact non profit groups and social services when they encounter families in distress. The Police frequently purchase groceries for elderly citizens after they answer a call at the residence and discover the residents don't have food in the house. Waynesville serves the wealthy residents on the mountain ridges and work to accommodate their service challenges that result from steep, narrow access roads and frequent power outages. We recognize that our topography and weather create anxiety for our elderly residents and the Town provides personal visits during inclement weather, especially when the power is out.

Will this grant help you address any equities and disparities? If so, which one?

The issue of how a Town of 10,000 residents deals with a growing population of homeless residents is splitting the community. The community sponsors two homeless shelters which were created to help residents of Haywood County that find themselves without habitation. Many are victims of rampant drug addiction, some have psychological issues, and some may have simply been kicked out of their parent's homes when they reach eighteen. The escalating homeless population is being caused by the popularity of our current homeless shelters and the law enforcement communities' recognition that homelessness is not a crime. Waynesville is receiving an influx of non-local homeless persons from all the western counties and other States such as Arizona, California, Alaska, Utah, and Georgia. Our inability to handle large numbers of homeless residents is driving them to break into business and residences to squat and steal items that they can sell for cash. The social dilemma that we face in Waynesville is a split in the community between citizens that wish to help the homeless in any way possible and the group that are the victims of the chronic shoplifting, robberies and begging. During a candidate forum the two groups squared off and after two hours of debate it became clear that Waynesville needs to hire a consultant that can provide expertise in strategies for dealing with community homelessness as well as skills in consensus building. With no one at the table that has a background in homelessness the Town sponsored "Committee on Homelessness with flounder.

Haywood County, the Town and developer Landmark Realty entered into a public - private partnership to repurpose the old Haywood County Hospital, located in Waynesville, with federal low-income housing tax credits to provide fifty rental units for veterans, persons with disabilities and low incomes earlier in 2019. The Town works closely with the local non-profit Habitat for Humanity organization and supports Mountain Projects, a Haywood County Community Action Agency, providing affordable housing and other social services to lower income residents. The Town supports the Open Door Ministries, a faith-based organization providing onsite meals and emergency assistance to persons in need, which includes persons without stable housing.

Waynesville Taskforce on Homelessness

Description of Current Need/Project

Tell us information about how the money will be used

There are increasing numbers of persons without housing in the Town of Waynesville. Police Officers have encountered approximately ten encampments of homeless persons, as well as others sleeping under bridges, in cars, and abandoned buildings. The numbers are impacting Haywood Pathways Center, a Waynesville faith-based non-profit, providing short-term shelter for up to sixty adults in crisis or chronically homeless. The shelter is often full and does not accept all individuals. During daytime hours persons must leave the facility. Some walk to the Open Door Ministry, located across town. Others experiencing homelessness walk to the Open Door as well. These persons are stigmatized because of their status as homeless. Business owners and residents complain to Town officials that these persons are dangerous, commit crimes and cause public nuisances. During a recent Town government election, all candidates agreed that preventing and ending homelessness were top issues and supported a taskforce to address homelessness.

This grant will fund a person who is knowledgeable about housing and homelessness issues, with a skill-set of data collection, group facilitation, collaboration, and strategic planning to coordinate the Task Force. He/She will be essential to insuring Task Force objectives are reached. Task Force objectives include:

- (1) With input from Town Mayor and Board of Aldermen, the coordinator will organize the Task Force on Homelessness and schedule meetings;
- (2) Coordinate research on the demographics of persons who are homeless in Waynesville and causes; inventory current housing stock and existing services available to prevent or respond to temporary and chronic homelessness;
- (3) Examine stigmatization, criminalization and discrimination associated with homelessness;
- (4) Conduct a gap analysis to identify needs, existing community capacity and additional resources necessary to prevent and respond to temporary and chronic homelessness, and
- (5) Develop a collaborative community action plan to fill system gaps and improve existing programs.

The Town of Waynesville serves everyone, regardless of race, color, creed, religious affiliation, sexual orientation or political beliefs. Residents are eligible for services if they reside within the geographic town limits. Our policies and procedures related to service provision do not differentiate between groups but rather concentrate on the efficiency and effectiveness of service delivery and working toward exemplary customer service to all. Waynesville is unlike many southern municipalities in that it has a racial breakdown of 92% White, 4.4% Latino and 2.7% Black. The Town's poverty rate is 22.2 percent. The most telling diversity is that of income and socio-economic status. Waynesville is made up of several groups: wealthy retirees who reside along the mountain ridges, small business owners, retirees from local industries now closed, working families, and young persons in school or working in the service industries.

The Town budget reflects our commitment to serve diverse groups. The Town provides one of the largest recreation programs in western NC. It prices its recreational amenities so that citizens at all income levels may participate. The Town runs a summer camp program that provides affordable summer recreation programs to help families who otherwise may lack summer day care. It provides financial support to numerous nonprofits that provide a range of services to Haywood County residents. Waynesville allocates funding for REACH, a domestic violence-sexual assault organization; the Open Door; the Pigeon Multicultural Community Center, which serves many of Waynesville's Black and Latino residents and Mountain Projects which provides affordable housing and other social services to low income residents of our community.

How does your organization embrace diversity? How is diversity reflected in your organization's board and staff?

Waynesville is unique among North Carolina Towns. It has a history of accepting newcomers with different political views and personal lifestyles. Its residents vary from wealthy retirees from Florida to "Sovereign Citizens" who don't recognize the legitimacy of the US government. The Town Board reflects the diverse nature of our community. The five-member board is comprised of both Republicans and Democrats, an openly gay member and a female Mayor Pro Tempore. The Town Manager is male, while the Assistant Town Manager is female. The Town Board is sensitive to the needs of all racial groups and income classes within the Town.

Tell us what equity means to your organization and how it informs the work of your organization? It is the policy of the Town of Waynesville to treat everyone with dignity and compassion regardless of income, race, gender, political affiliation, sexual orientation or social status. As they move through the workday, Town employees are alerted to social conditions in the community and frequently contact non-profit groups and social services when they encounter families in financial or other distress. As set out above, the Town budget reflects the values of equity: all persons should be free from intimate partner violence; persons should be able to access food and access affordable daycare and recreation. The Town supported the founding of the Waynesville Housing Authority so that persons could obtain housing, regardless of their income.

With the support and facilitation of the Task Force Coordinator, the Task Force on Homelessness will develop a community action plan to address health inequities correlated with homelessness. The American Public Health Association states, "Ending homelessness is a public health issue, as those experiencing homelessness have high rates of chronic mental and physical health conditions, co-occurring disorders and barriers to care." Persons experiencing homelessness are less likely to see a doctor and more likely to access emergency services when necessary. Persons experiencing homelessness are less likely to comply with prescribed medications. Research indicates that children are more likely to succeed in school and have better job prospects in the future when they don't suffer the stress of wondering where they will sleep. The correlation between disabilities and homelessness is high, with almost 20% of individuals experiencing homelessness in 2016 reporting severe mental illness, and 17% reporting chronic substance use problems, according to national reports.

With the support and facilitation of the Task Force Coordinator, the Task Force on Homelessness will develop a community action plan to address housing inequities related to homelessness. The Task Force Coordinator will support and facilitate the Task Force's examination of community experiences in securing and maintaining safe, affordable housing. The Task Force will investigate services necessary to accessing housing and helping people maintain their housing once housed. The Coordinator will help provide data concerning assistance, services received and gaps in services needed by persons experiencing homelessness through research and data collection. While less than 15% of the homeless population is "chronically homeless," the Task Force will examine their needs and the community resources available to them.
