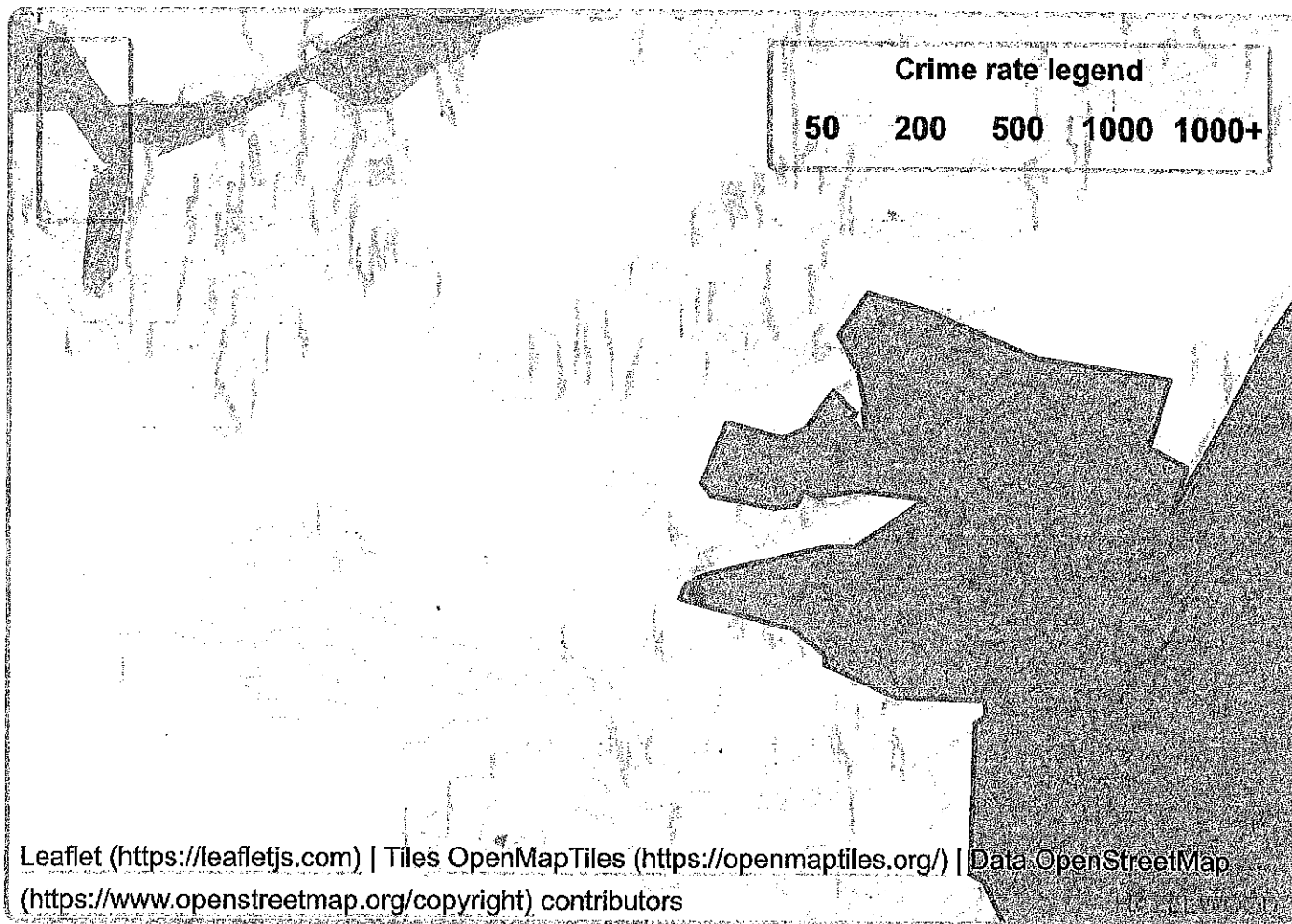

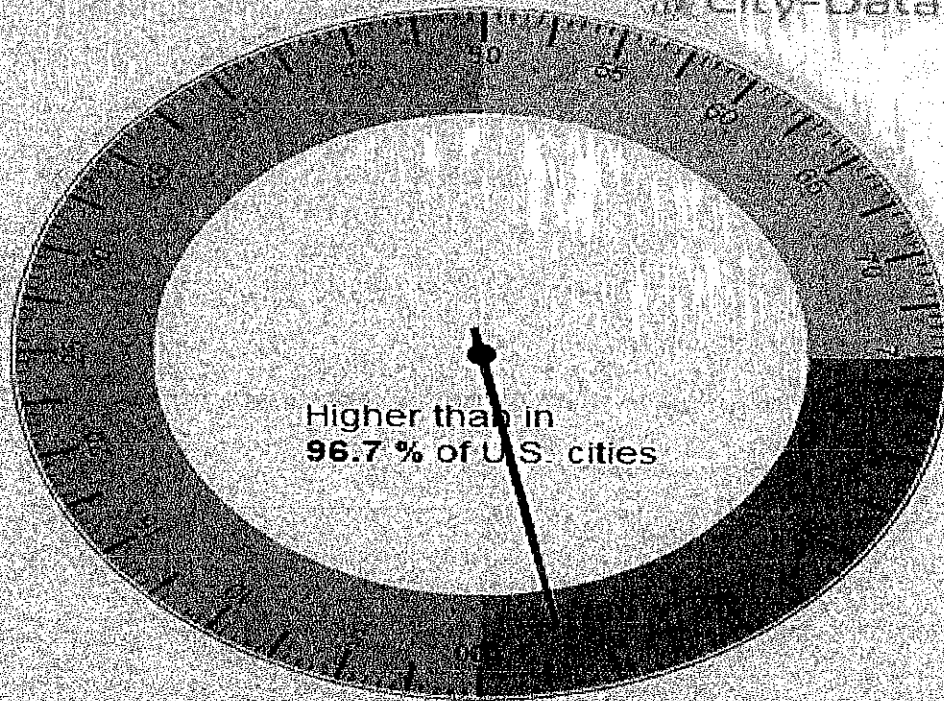
Crime rate in Waynesville, NC

The 2019 crime rate in Waynesville, NC is 539 (City-Data.com crime index), which is 2.0 times higher than the U.S. average. It was higher than in 96.7% U.S. cities. The 2019 Waynesville crime rate rose by 37% compared to 2018. In the last 5 years Waynesville has seen rise of violent crime and increasing property crime.

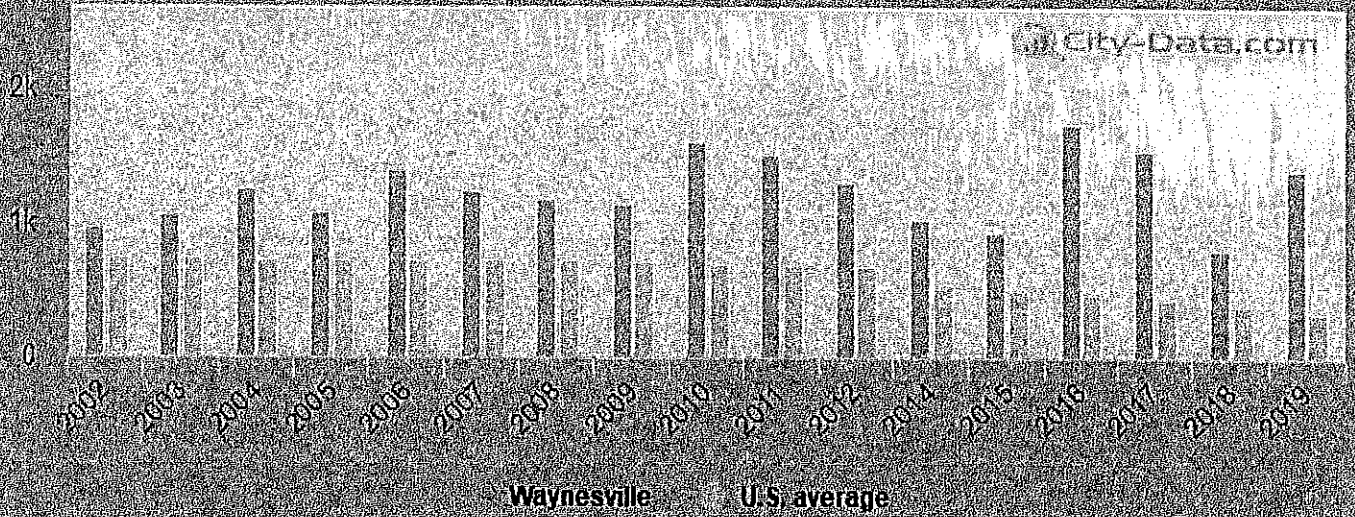
Robberies per 100,000 population



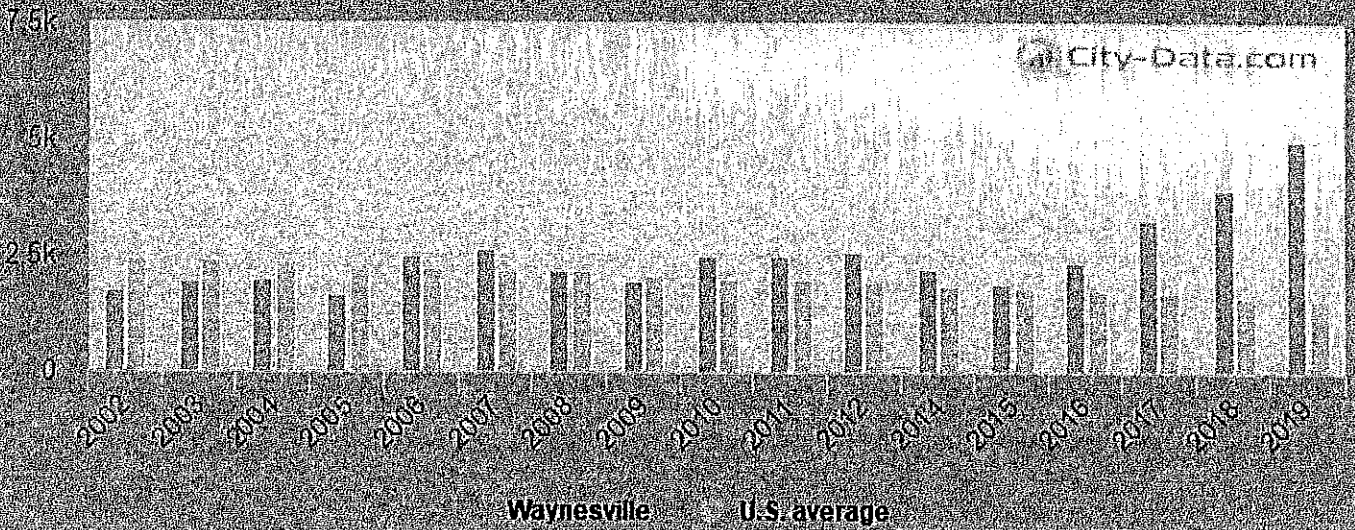

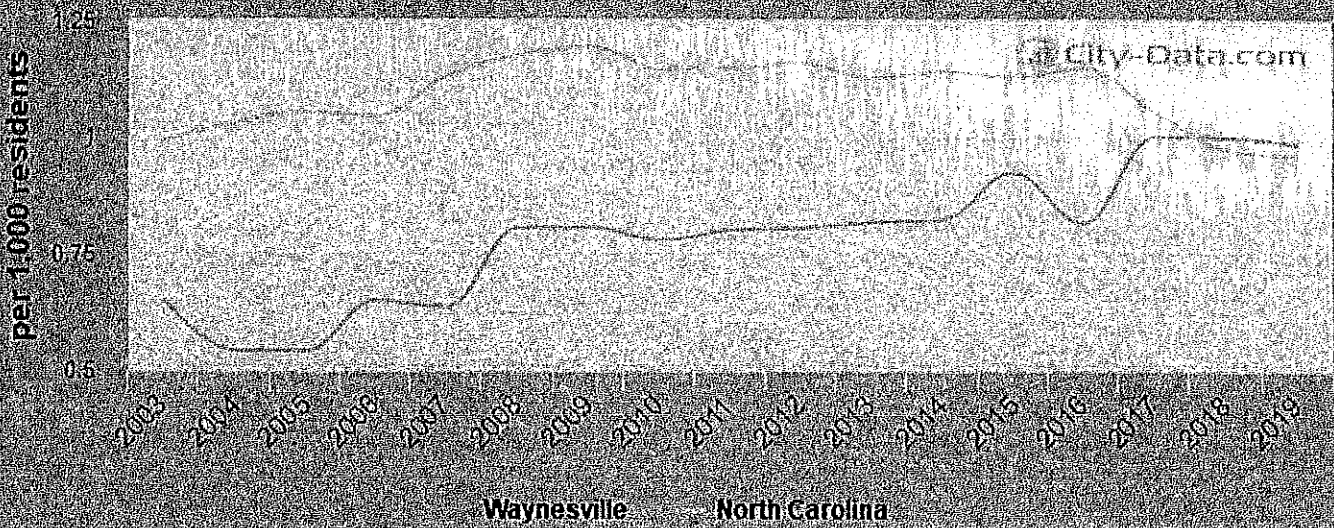

Full-time Law Enforcement Employees - Officers

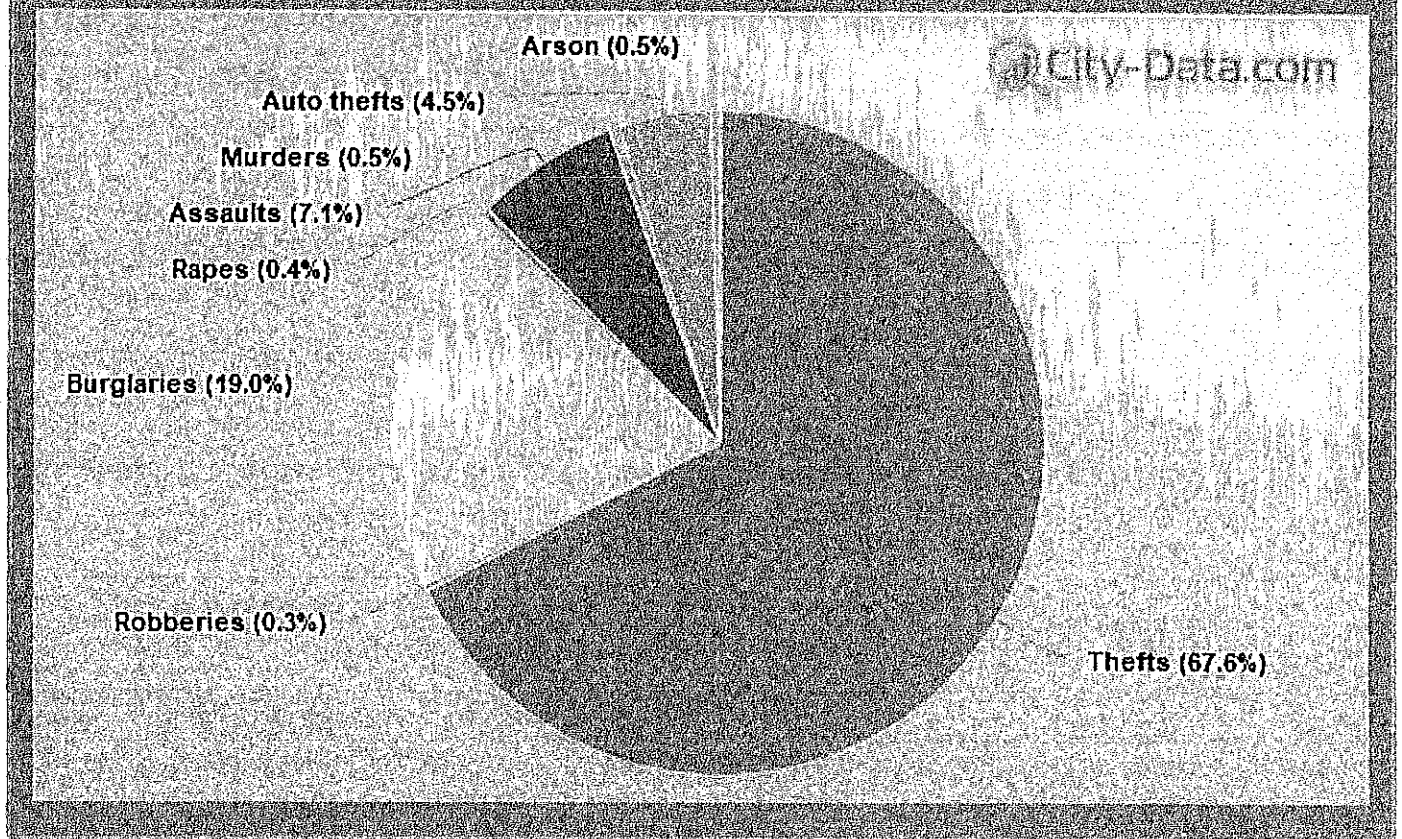


Full-time Law Enforcement Employees - Civilians

What is the crime rate in Waynesville, NC?

According to the most recent data from the [FBI](#), the total crime rate in [Waynesville](#) is 7,362.5 per 100,000 people. That's 197.27% higher than the national rate of 2,476.7 per 100,000 people and 169.78% higher than the [North Carolina](#) total crime rate of 2,729.1 per 100,000 people.

Note: Because the rates of crime are so low in America, we use "per 100,000 people" to make the number a bit easier to compare across locations visually. It's mathematically the same as doing per capita comparisons and isn't conveying that there are 100,000+ people in a location.

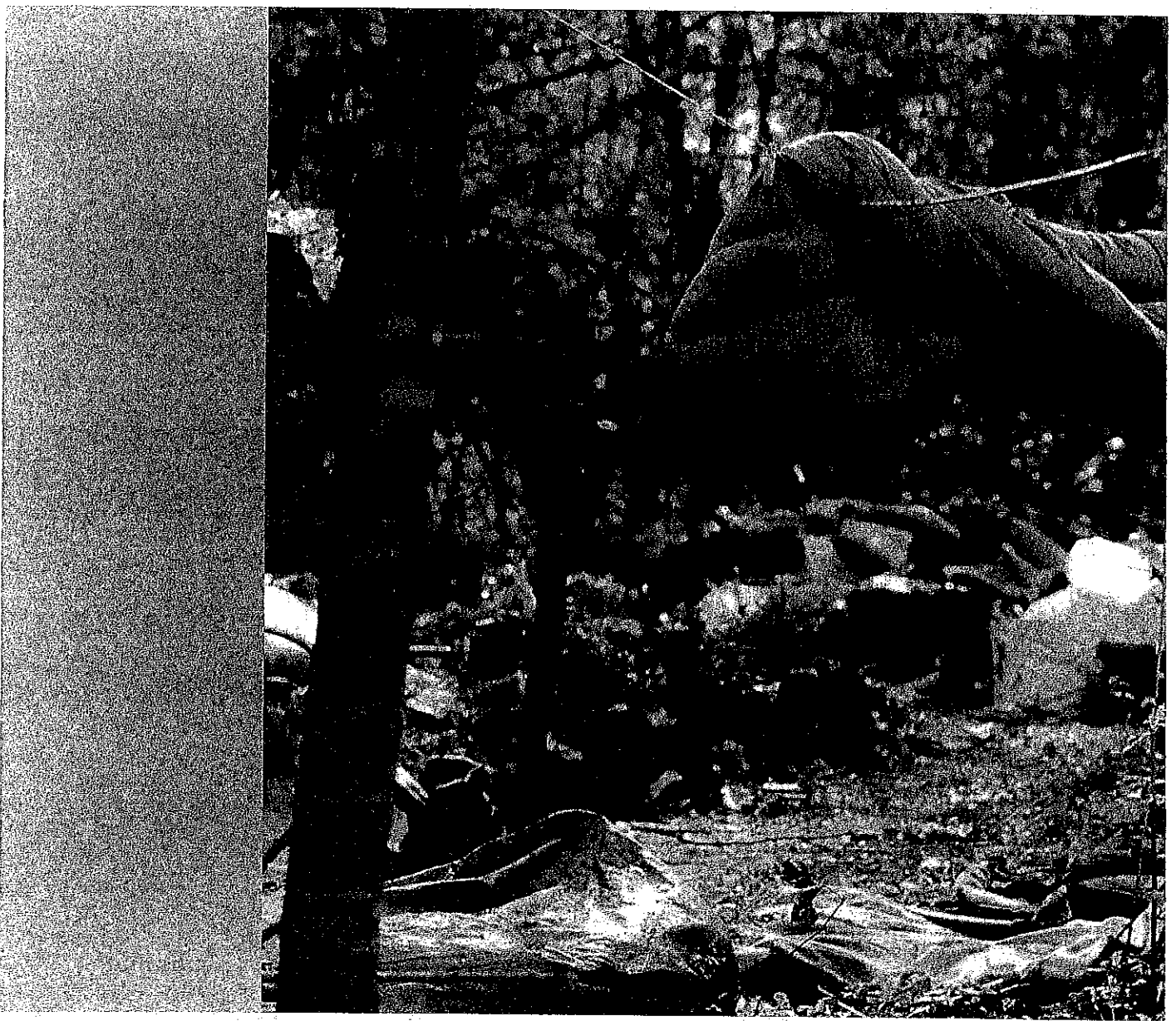

Waynesville cracks down on influx of homeless people sleeping in town parks

A spike in homeless people sleeping in public parks in Waynesville has prompted a new 9 p.m. curfew for public town property.

The new curfew ordinance will give police the authority to kick overnight campers out of town parks and arrest them for trespassing if they refuse to leave. Until now, police lacked recourse because there wasn't a law on the books making it illegal to sleep overnight on public town property.

The final straw came a couple months ago when a couple of homeless people spent multiple nights in the wooden structures at the children's playground at the rec park.

“Can you imagine taking your 3- or 4-year-old there to play in the morning and finding people living in the playground castle?” said Town Manager Rob Hites.

Homeless people scouting for places to bed down have sought out other town property as well.

“Not just parks, but every right-of-way and piece of property we own,” Hites said. “They are even living in our culverts.”

Police were initially befuddled by the new trend. They now believe the growth in the homeless population is due at least in part to word getting out about the Haywood Pathways Center, a nonprofit homeless shelter in Hazelwood.

Its mission is to help local homeless people get back on their feet and re-enter society, with an emphasis on getting jobs and finding stable housing of their own. But police have encountered outsiders coming here in hopes of a free ride.

“We are getting people from as far away as California and Arizona now who are going to our homeless shelter thinking there is free room and board and find out they are full,” Hites said. “So they go to Walmart and get a tent. We are becoming a camping area.”

The 60 beds at the Pathways Center have been at capacity for a few months now. Even if it wasn't full, however, many outsiders don't meet Pathways' criteria anyway — either due to drug and alcohol use or not meeting the local litmus test.

The Pathways Center will only accept people who have been in Haywood County for at least 90 days.

“This is a community project for Haywood County and we really hold to that as best we can,” said Mandy Haithcox, the executive director of the Pathways Center. “This is not a place to come as a destination.”

Haithcox said she routinely gets calls from people out of the area wanting to come here.

“We are the only shelter between here and Murphy. If you are looking for a place to start over, it’s hard,” Haithcox said. “But we make it very clear that if you are coming to relocate here, you will be homeless here also.”

Theoretically, someone could come here and live on the street for 90 days to meet the local requirement, or just lie and say they have been in Haywood County for 90 days already. But she thinks that’s rare.

“It is a small community, so it is pretty easy to figure out if they are from Haywood County or not,” Haithcox said. “It is not like being in a big city where everybody is anonymous. We have been very adamant to sticking to the agreement that we would take care of Haywood County first.”

Nonetheless, police say they are encountering people who came here after hearing about Pathways and then end up on the street.

“I’d love to put you in my car so you could look at the property destroyed, the camps set up and the crimes taking place,” Waynesville Police Captain Brian Beck told town board members last week during a discussion of the issue.

There’s also been a rise in homeless people camping on private property, from vacant lots and patches of woods to abandoned sheds. Police can arrest anyone camping on private property, but until now, their hands were tied if it was public town property.

“We didn’t have an ordinance that gives us the authority to arrest someone if they refuse to leave,” Hites said.

While officers would try asking them to move on, they wouldn’t always comply.

Balancing act

Rumors have circulated over how homeless people from other places hear about the Pathways Center. One is that the Pathways Center ended up on a national online registry of homeless shelters. Another is that a probation officer in a state out west was telling people to come here. There's even a rumor that homeless people from other states were given bus tickets to Waynesville.

But none of the rumors are confirmed, and they certainly aren't the Pathways Center's doing.

Haithcox said there are plausible reasons for any increase in the homeless population. One is the ruinous consequences of the opioid crisis. Another is the affordable housing shortage.

"The challenge is finding a place to live," Haithcox said.

The severe lack of affordable housing has driven up rents. With demand exceeding supply, landlords are jacking up their rent, so even though half of those who live at the Pathways Center have jobs — many of them full-time jobs — they can't afford the little housing that's out there.

As a result, the Pathways Center has found itself habitually full the past few months and has had to turn people away.

. That should be eased some with the addition of a new dedicated women's and children's building, but that, too, has attracted interest from out of the area.

“We've already gotten calls from other counties wondering when are going to be open and we tell them we are only going to be available for Haywood County residents and we do that every day,” Haithcox said. “It's not fun when they are crying on the other end.”

Brown said the Pathways Center has helped scores of people rebuild their lives and the community is better off for the work they do.

“It is still a good thing they are doing here,” Brown said.

It's now just a matter of finding a solution for the unintended side effect.

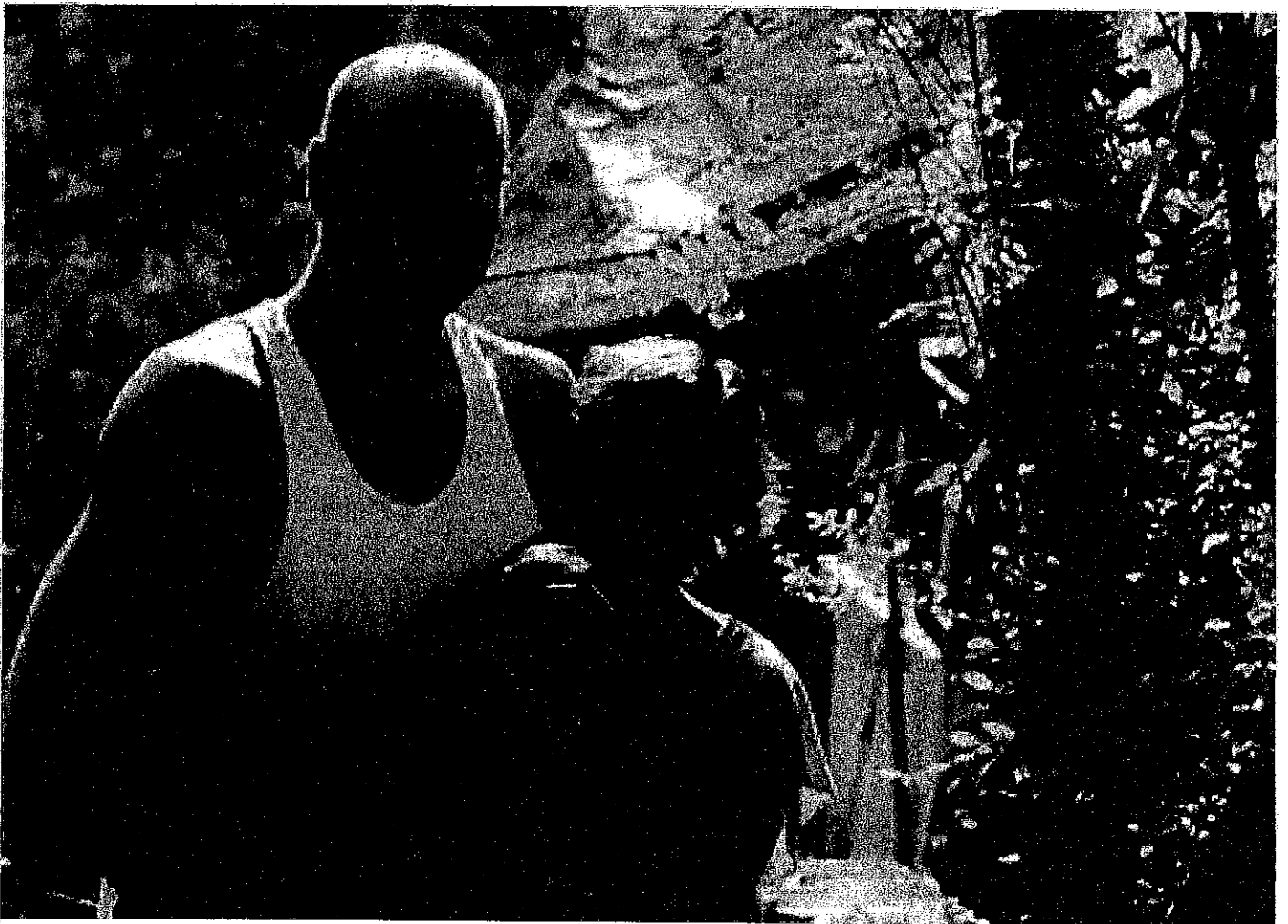
“When you push one side of the balloon sometimes it comes out the other side,” Brown said.

Exceptions to the 9 p.m. curfew for town property will be made for special events and gatherings by getting a special permit from the town. Waynesville Mayor Gavin Brown asked whether there should also be an exception for sidewalks and streets. Hites agreed.

Town Attorney Bill Cannon said it is difficult to anticipate every possible scenario — with this or any ordinance. Should logistical issues arise along the way, particularly if trespassing cases stemming from the

ordinance land in court, the language may need to be tweaked down the road, he said.

Waynesville antes up to house homeless people in hotels

A \$70,000 financial pledge from the town of Waynesville over the next two years will help the grassroots nonprofit Helping Hands of Haywood further its mission of serving as a stepping stone for homeless people on a path toward a new life.

The money will be used for temporary lodging in hotel rooms, with the \$70,000 covering roughly 1,000 room nights for homeless people over two years.

“I think it will provide a myriad of benefits to our community and the unsheltered folks who reside here,” Waynesville Alderman Jon Feichter said. “I think it is a win-win for all concerned.”

The town board voted unanimously to allocate the money out of \$3 million in federal COVID relief funds coming to the town.

“Helping with homelessness expenses is certainly one of the allowable uses,” Alderman Chuck Dickson said of the federal COVID money.

For the first year, Helping Hands will receive a quarterly allocation. As a condition of the funding, Helping Hands will have to make quarterly presentations to the board on its activities. It will get a lump sum of \$35,000 the second year.

Helping Hands was formed in 2020 to support homeless people who may otherwise fall through the cracks by connecting them with services and resources in the community, creating a network of support in conjunction with 15 other agencies and nonprofits. Providing temporary shelter in hotels is a critical first step that segues into other services, from addiction counseling to job training programs.

“Sometimes they are afraid of rejection or shame,” said Korri McLaughlin, a Helping Hands board member. “We guide our participants to other agencies they either don’t know about or are afraid to reach out to. We work with other nonprofits and social services to fill the gaps and achieve positive outcomes.”

Helping Hands is an all-volunteer initiative that helps homeless people navigate everything from getting to doctor’s appointments, obtaining legal documents like IDs and financial counseling. The first four months of 2021 Helping Hands assisted an average of 65 homeless people a month with hotel rooms, relying solely on private donations and support from the faith-based community.

“We believe everyone is a human and deserves to be treated as a human,” McLaughlin said. “Every Waynesville resident deserves a roof over their heads, meals on the table, and avenues to sustain daily living.”

The clients supported by Helping Hands aren't candidates for the Pathways Center, either due to active drug and alcohol addiction, mental health barriers to congregate housing or families facing a temporary emergency.

"We work diligently to find hotels willing to help on a case-by-case basis," she said.

Waynesville leaders questioned why the county wasn't supporting the initiative, as well.

McLaughlin said nearly all of those put up in hotels are Waynesville residents. But Mayor Gary Caldwell questioned whether it's accurate to categorize a homeless person as a Waynesville resident simply because they ended up inside the town limits, versus actually being from Waynesville initially.

"If they are homeless, you don't know where they are from," Caldwell said.

Some members of the public have criticized the use of town money to put up homeless people in hotels.

"Housing them in hotels at taxpayers' expense does nothing," said Lisa Overhultz, a member of the Saving Haywood coalition. Overhultz said it is tantamount to "enabling junkies that contribute nothing to the community."

Homeless people actively using drugs and alcohol can't get into the Pathways Center program, but no such requirement is placed on those getting hotel room assistance.

“Does this not amount to a de facto low-barrier homeless shelter?” Erich Overhultz said of the hotels being used.

The town's current zoning laws don't allow low-barrier homeless shelters, but that could change pending an ongoing debate over where, if anywhere, they should be allowed.

PROPERTY CRIME COMPARISON (PER 1,000 RESIDENTS)

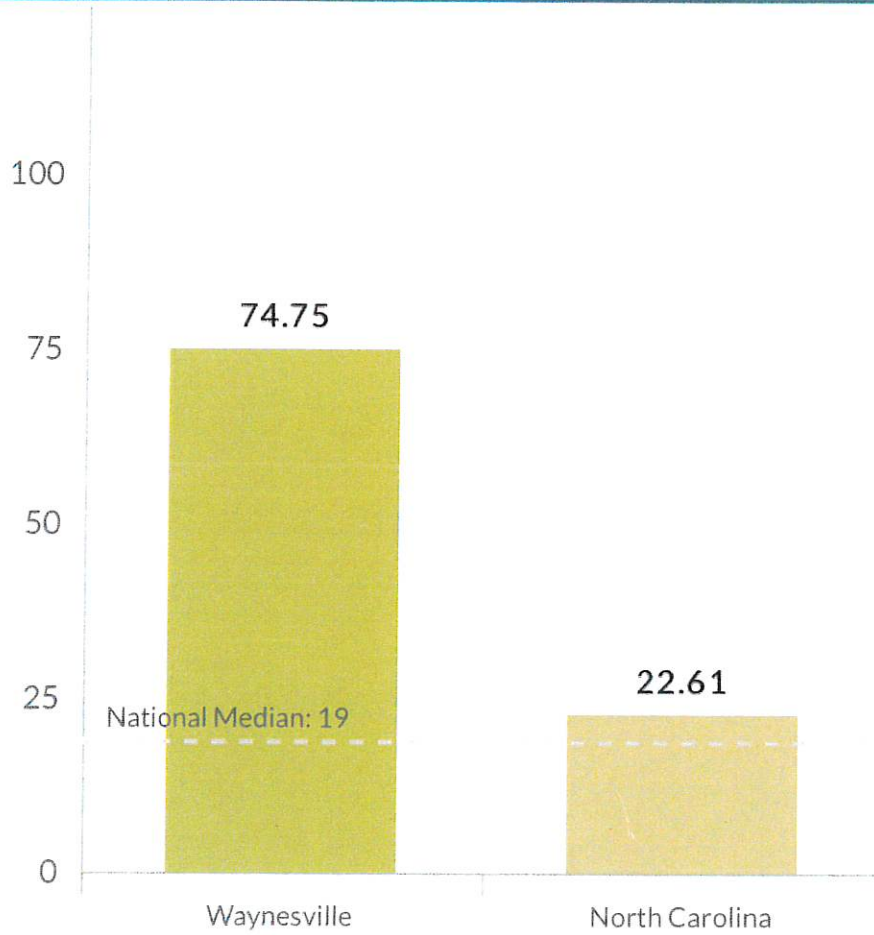

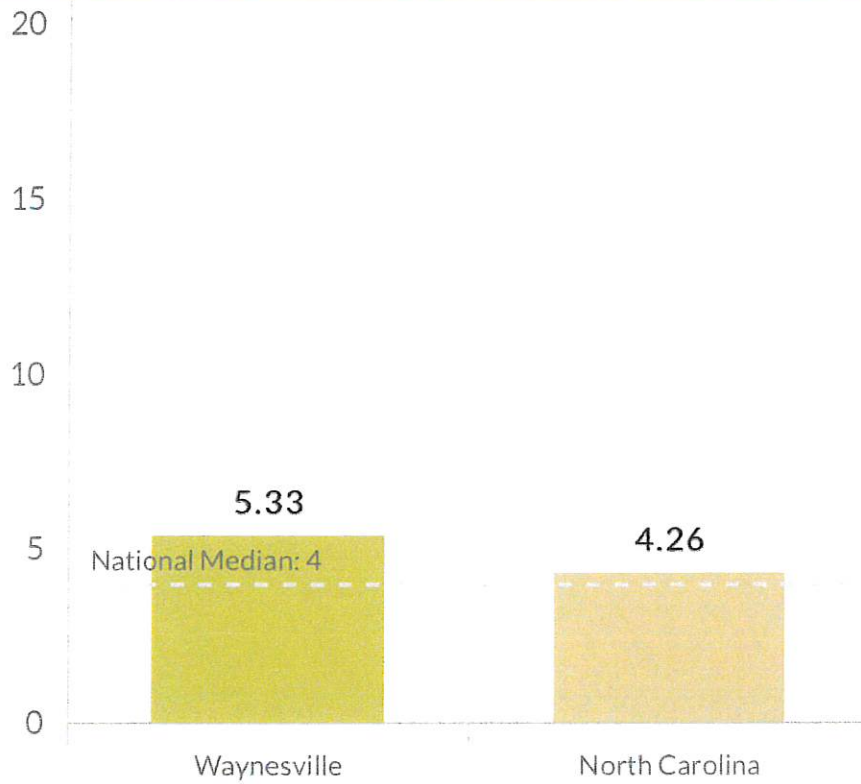
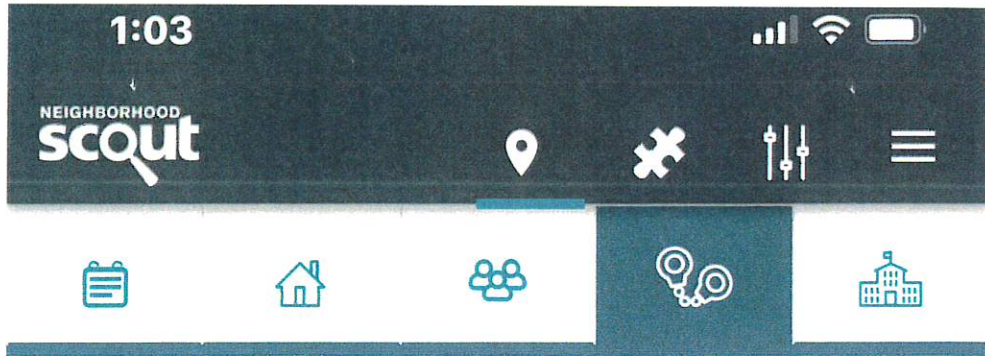
