Fowler told aldermen they would be permitted to come by town hall and look at the receipts if they wanted, but it couldn't be publicly disseminated.]

Discrepancies have arisen with the AGREEMENT OF PROGRAM SUBSIDY TO TEMPORARILY HOUSE INDIVIDUALS EXPERIENCING HOMELESSNESS (a.k.a. the Confidentiality Agreement) between the Town of Waynesville (i.e. Gary Caldwell, Mayor / Eddie Ward, Town Clerk) and Nicole Kott, *Executive Director* of Helping Hands of Haywood. I recommend that you have the town lawyer, Martha Sharpe Bradley, look into this matter, and determine the validity of this contract prior to the Aldermen Meeting Tuesday, 1/25/2022 at 6:00pm.

Specifically, there seem to be irregularities with:

- Eddie Ward notarization of Helping Hands of Haywood (a perceived conflict of interest), and
- Nicole Kott portraying herself representing Helping Hands of Haywood as Executive Director.

Generally, notaries cannot notarize for themselves, family members, etc. Why on God's Green Earth did the Town have Eddie Ward perform the notary for Nicole Kott, when Eddie Wards signature also appears on the last page of the contract as Town Clerk? Why even give the appearance of impropriety?

Please review the last two pages of the AGREEMENT OF PROGRAM SUBSIDY TO TEMPORARILY HOUSE INDIVIDUALS EXPERIENCING HOMELESSNESS (a.k.a. the Confidentiality Agreement).

The first two images are pages 6 and 7 of the AGREEMENT OF PROGRAM SUBSIDY TO TEMPORARILY HOUSE INDIVIDUALS EXPERIENCING HOMELESSNESS (a.k.a. the Confidentiality Agreement), showing clearly the notary pages and the signature page.

The second two images are from the NC Secretary of State Website, depicting the most current Articles of Incorporation for the Non Profit Corporation - Helping Hands of Haywood, listing Nicole Kott as the PRESIDENT, not the Executive Director. It is noted that Helping Hands of Haywood, Item 6 (b) indicates that the Corporation will not have members. So, did Nicole Kott demote herself to the new title of Executive Director, or did she purposely misrepresent herself to a Notary (Eddie Ward) as being the Executive Director of Helping Hands of Haywood?

Under any circumstances, you need to get *an opinion* from your town lawyer, Martha Sharpe Bradley to see if she can hold it together and keep this Agreement from being thrown in the trash can, and having to start from scratch and renegotiate the whole thing over, and do this before the next Aldermen meeting, Tuesday, 1/25/2022 at 6:00pm.
