Subject: The NO PARKING sign installed at the end of Johnson Hill Drive by the Town of Waynesville.

Your response to my Request for Public Information was the wrong answer.

On "September 13, 2021, two guys wearing work vests hammered the No Parking Sign where it is. **Ed Smathers** and **Dennis Ramsey** were jumping up and downing laughing and chapping their hands on 146 (Johnson Hill Drive) property. They told Joe (Lipari) to move his SUV from the road because they would call police and he would get a ticket."





NO PARKING sign installed at the end of Johnson Hill Drive, facing towards the dead end.

This is one of the most horrific instances of Intimidation and Abuse of Power by the Town of Waynesville and others (and we will get to the "and others") that I have come across in a long time. The quote above is from a very distressed Lois Hollis, who lives with Joe Lipari at 156 Johnson Hill Drive, at the dead end of the street. **Ira Dove** lives across the street from Lois Hollis. The NO PARKING sign was installed by the City across the street from property owned by Ed Smathers at 146 Johnson Hill Drive as a punitive measure against Lois Hollis and Joseph Lipari.

The sign was specifically installed to harass an elderly couple beyond belief, i.e. Elderly Abuse. An example of harassment inflicted by **Ed Smathers** and **Dennis Ramsey** is shown on a short video clip taken by Joseph Lipari, from behind the "fence from hell" pointing towards the two yelling and communicating threats from **Ed Smathers** porch at 146 Johnson Hill Drive.

I wanted to understand the complicity the Town of Waynesville had in the installation of this sign. I took as the starting point of this matter as the request for this sign having been approved by the Town of Waynesville Board of Aldermen. I requested some seemingly innocent information as to the process that took place by the Waynesville Public Services Department, to understand how this could possibly happen. I made a Requested for Public Information to you, Mr. Stines, on 4/6/2022, and you provided a response on 4/12/2022, in which you appended your response in red (Italic). In part,

... Any and all work orders for a No Parking Sign that was installed at the end of Johnson Hill Drive, facing towards the end of the road. This includes every documentation from cradle to grave. No work orders were created for this task. This was relayed verbally to that specific Department Head based on the BOA approval of the installation of said signage. ...

and ...

... I am interested in the documentation path that was taken once this action was approved by the Board of Aldermen, including but not limited to drawings for the location for the sign to be placed, drawings indicating the direction the sign was to face, who signed off on everything, dates, ordering of the sign, and anything else related to the installation of this No Parking sign. As stated above, no work order/drawing was created for this task. WTF?

You don't do work orders?

WTF?

Is everything verbal?

Is that why the Town of Waynesville Sewer System is FUBAR?

You don't do work orders?

Rob Hites is now planning to borrow \$23.6 Million to fix this Sewer System catastrophe. When the new construction commences, who is going to be overseeing this operation? The guy who does not do work orders? I don't think so. I am inclined to make a recommendation I rarely make, and that will be to get more involvement in this new Sewer System by State and Regional government employees. (More government???)

Perhaps you should consider requesting having the Town of Waynesville send you to Work Order School and retake the refresher course - How to Create Work Orders 101.

Let's start from the end and work to the beginning...

You indicated: "The sign was placed where the violation of on street parking was noticed by the staff of the Town of Waynesville Public Services and Waynesville PD." You have now dragged the Waynesville Police Department into this incestuous cesspool.

Do you happen to "remember", since everything appears to be verbal, the following?

- What and where this violation of on (sic)street parking took place?
- Do you have photos of these alleged parking violations?
- Who were the staff of the Town of Waynesville Public Services employees you referred to? Names please.
- Who were the officers from the Waynesville PD that observed this violation that you referred to? Names please.
- Who were the two employees that actually installed the sign on 9/13/2022? Names please.

I am not in the habit of making a Request for Public Information on issues that are verbal in nature, so I guess I am not really expecting a response to the above questions, since everything is verbal, and there are no work orders.

Backing up to the very beginning, let's see if this scenario doesn't refresh your recollection a little bit.

Jesse Fowler and Ed Smathers come marching into the office of Chris Snyder – Streets/Sanitation Superintendent, csnyder@waynesvillenc.gov, and demand he place a NO PARKING sign at the end of Johnson Hill Drive for the purpose of harassing the elderly couple at the end of the street. (Unfortunately, Ira Dove lives across the street from Hollis/Lipari, but he is a quiet guy and won't kick up a fuss.) This is escalating to the level of the Hatfield's and McCoy's. This property is owned by Ed Smathers, who he rents out to Sharon and Dennis Ramsey (of video clip fame). It is alleged that the property at 146 Johnson Hill Drive used to be a crack house, hence the problem with parking.

Does that jog your memory?

Photo Showing a Waynesille garlage truck somewhere on Johnson Hall Dr. The following is the actual .jpg of the garbage truck driving off the pavement, obtained from Eddie Ward on 4/4/2022, following a Request for Public Information (photo labeled 21-Aug-10-4c):



This photo may or may not have been taken on Johnson Hill Drive, but under any circumstances, it is no where near the location that the sign was actually placed. There is no grass anywhere near where the sign was installed. This is a misleading photo, indicating that a garbage truck is having difficulty negotiating parked cars somewhere on Johnson Hill Drive, but in no way shape or form, is it related to your statement: "we have also had complaints from citizens not being able to access driveways, etc."

The Board of Aldermen were clearly mislead when they approved this NO PARKING sign on Johnson Hill Drive when they observed this photo in their agenda package.

4. No Parking Signs

Jeff Stines, Public Services Director

Mr. Jeff Stines explained to the Board that there had been several issues and complaints by citizens on different streets with large trucks and equipment navigating around parked vehicles, and not being able to access their driveways due to the on-street parking. The Board was referred to the pictures in their Board packets showing the parked cars and the limited space for the trucks. He said this was a big liability of injury to employees and damage to trucks or equipment. Mr. Stines stated that the signs would for no parking on either side of the streets.

Alderman Feichter asked Mr. Stines to consider Hemlock Street for no parking signs as well.

A motion was made by Alderman Jon Feichter, seconded by Alderwoman Julia Freeman, to install "No Parking" signs on the following streets (Prevost Street, Daisy Avenue, Johnson Hill Drive, Morning View Road, Calvary Street, Hemlock Street and Ethel Lane.) The motion carried unanimously.

Petitions for Traffic Calming Devices

Jesse Fowler, Assistant Town Manager

Mr. Jesse Fowler, Assistant Town Manager told the Board that the Town had received three completed petitions for traffic calming devices. The locations of these approved by J. M Teague and are recommended to have traffic calming devices placed on the following streets:

- 1. <u>Auburn Road</u> speed humps
- 12' length x 3" height
- JM Teague Estimate: \$10,400
- 2. Hendrix Street speed table
- 22' length x 3"
- JM Teague Estimate: \$24,800
- Ninevah Road speed humps
- 12' length x 3" height
- JM Teague Estimate: \$15,200

The funding for the devices will come "Infrastructure Paving and Improvements" (Powell Bill.)

Additionally, there are no less than twenty (20) criminal and civil complaints that have been filed against Lois Hollis and Joseph Lipari by **Sharon** and **Dennis Ramsey**.
