This is an email dialog with David Adams, Waynesville Chief of Police, requesting to be put on the list of people who are provided with Press Releases from the Waynesville Police Department. This gets strange.

A couple of recent events prompted this Request for Public Information.

• The Waynesville Police Department held a Community Meeting, that was held at 6:00 PM at 112 Virginia Ave., Waynesville, NC on 6/2/2022. During that meeting, Tyler Trantham gave a slide show presentation. In included several slides, as the one shown here -



I had requested copies of this presentation, but have yet to receive them.

The following appeared on Chad Nesbitt's facebook Skyline News page on 7/21/2022, -



This is a "News Release", ostensibly put out by the Waynesville Police Department. Notice that there is an apparent distinction between a "News Release" and a "Press Release".

Since then, I became aware [re: 'A new calling: Respected Waynesville PD lieutenant leaves law enforcement in his prime', Written by Kyle Perrotti, Wednesday, July 27, 2022.

https://smokymountainnews.com/news/item/34026-a-new-calling-respected-waynesville-pd-lieutenant-leaves-law-enforcement-in-his-prime] that Tyler Trantham was posting these "News Releases" on the Town of Waynesville Police Department Facebook page. Tyler Trantham has announced that he is leaving the Waynesville Police Department.

WTF?

Chad Nesbitt has both a Facebook page,

and a website

His website appears to be updated infrequently, and most current stuff is on the facebook page.

Full Disclosure. I am not on Facebook. I was once, attempted to delete the account, but Zuckerberg will never let you delete an account. You can only go dormant. From the dormant stage, one can still access limited portions of a public facebook page, as I have done with Chad Nesbitt's facebook page, which is where I saw the post about a homeless person who lived in a tent and died due to a fentanyl overdose, right behind Best Buy. I waited a couple of days to see if this was ever picked up by our two local liberal newspapers. It never was.

WTF?

I personally don't consider ever getting news from any facebook page, nor had I ever known the Waynesville Police Department had a facebook page, let alone that they were posting "News Releases" on that page.

I have since discovered the location of the Waynesville Police Department facebook page, and did indeed locate the "News Release" that Chad Nesbitt picked up. Since I never log into facebook, I have limited access to reader comments and posts, but I did notice two distinctly different trends:

- Posts on the Waynesville Police Department facebook page were generally complementary of the fine job the Waynesville Police were doing, while,
- Posts on Chad Nesbitt's page for the same "News Release" were diametrically opposed to those found on the Waynesville Police Department page. In fact, the individual was identified as "Virgil" from Kentucky.

WTF?

We (Concerned Citizens of Haywood) have been consistently told by Waynesville Police Department employees that "We know all the homeless people, and they are all from Waynesville. There is no one from out of town."

WTF?

So, I made the request to receive "Press Releases" from the Waynesville Police Department, and start posting these, because, sure as [expletive deleted], our two local papers are not going to do it.

Here we go, and at this point, I have yet to receive the first "News Release" or "Press Release".
