"Town Manager **Rob Hites** announced that due to the recent threats that have been made to the elected officials, and Public Service employees, <u>the Police feels it necessary</u> to follow the lead of Haywood County and begin to use metal detection for people entering the Board Room. He reminded everyone that it is nothing personal, but it is for the protection of everyone in attendance."

WTF?

That is not what happened [re: audio of the meeting], yet **Rob Hites** gave several interviews about this new procedure to local media, including WLOS.

Well, while **Rob Hites** was telling everyone in the room they were taking the lead of Haywood County Commissioners and using metal detection for county commission meetings, I was minding my own business, sitting in the back of the room, shaking my head "no", when Chief David Adams notice my incredulousness of this guy **Hites**. Chief Adams got up from his chair, walked over to me (which he never does), with a questioning look on his face. I explained that **Mark Swanger** (ex FBI guy and county commissioner) installed a metal detector at the old courthouse, but that was removed years ago, and county commissioners no longer screen anyone going into the old courthouse.
