This is not out of the ordinary in any way, Greg did not have his own cash drawer for the same reasons listed above, but he would process checks when needed.

Subject: Surety Bond Update

Good Evening –

After exhaustive efforts we have obtained a surety bond for the new Tax Collector Elect in the amount of \$250,000. While this amount is less than we were seeking, there is no statutory requirement on the bonding amount. I have crafted a risk management plan for the Tax Collection office as outlined below:

- Quarterly internal audits will be completed by the Internal Auditor and reviewed by the Finance Director
- Tax Collector will have non-transactional access to the collection software (this is standard practice in place already)
- Daily bank deposits will be handled by staff only

This plan can be revisited and adjusted on an as-needed basis.
