We are going to explore some messy stuff here, which includes the (now defunct?) Economic Development Council, which is connected at the hip (slight pun here) to the Haywood Chamber of Commerce. Who is on this Economic Development Council, and what have we received for the hundreds of thousands of dollars (not nearly Six Million) that have been poured into this arrangement?

The Haywood Chamber of Commerce, a.k.a. Greater Haywood County Chamber, is a 501(c)6 corporation, and not subject to Public Information Requests, much as **Sarge's** (see entire section on **Sarge's** on www.haywoodtp.net under Interesting Stuff archives). It is not clear at this point what the Economic Development Council even is, nor who to contact.

So this will be an interesting story to follow, which you will not see in either of the two local papers, the mountaineer nor the smn tabloid. Although **Scott McLeod**, Editor of the smn tabloid, has been identified as past chair of the Chamber of Commerce.

This starts out with the following bits and pieces, and left to the reader to connect the dots.

- My public comment on the Economic Development Council,
- My Request for Public Information relating to contracts between the County and the Chamber,
- An "interesting" email dialog with CeCe Hipps, President of the Chamber of Commerce.
