Dissecting your "Guest Column's", Letters to the Editor and your emails is reminiscent of going back to my high school days in Biology when I dissected my first frog. Now, I am dissecting a duck (i.e., quack). It keeps the mind sharp.

I don't know if you are aware, but I am now posting responses to your "Guest Column's", Letters to the Editor and emails directly on my website. The reach now is far greater than simply the folks you refer to in your question to me. In fact, this reminds me of a funny incident while Rusty McLean was taking a deposition from me a while ago in his office [re: recording], and the object of the deposition turned to interactions between him and I. So you must imagine my confusion in your email to me dated 3/6/2023, when you all of a sudden put Sarah Banks on your copy list, instead of Sarah Henderson.

Who is Sarah Banks? Certainly no explanation from you. Did Sarah Henderson get divorced and go back to her prior name? Did she get married? Still waiting for you to have Ira Dove and Bryant Morehead to clarify you statement that "Ira Dove did not demand the venue.", and, since you seem to be providing communication for Sarah Banks and Ira Dove, when the next suggestion for a meeting date will be, and we sure want to make sure Sarah Banks is in agreement. Then, Terry Ramey can coordinate these new proposed dates with the folks that will be joining him in the meeting. Again, Bryant Morehead is welcome to attend based on his position as county manager, but not as a person joining the conversation at the meeting.
