Subject: Email Dialog with **Joey Webb, Jr.**, CGCIO, re: Ramey phone dump to **Cory Vaillancourt**.

This is a continuation of the never ending battle to get **Joey Webb, Jr.** CGCIO to cough up the personal confidential information Haywood County (**Joey Webb, Jr.**, CGCIO + **Frank Queen**) pulled out of Terry Ramey's personal cell phone and gave to **Cory Vaillancourt**, smn tabloid.

Joey Webb, Jr., CGCIO had been stalling, on the premise of saying there were people in the queue who had requested Public Information before me, therefore, I had to wait until **Joey Webb, Jr.** CGCIO took care of that business. What **Joey Webb, Jr.**, CGCIO didn't really bother to disclose was that it was **Cory Vaillancourt's** requests that they were processing.

After **Joey Webb, Jr.** CGCIO sent another round of Terry Ramey's personal cell phone information, **Joey Webb, Jr.** CGCIO resent the whole glob to me the next day, 6/26/2023.

I received 1732 lines of individually wrapped items. I accessed the first (and only) one which indicated an upload date of 6/23/2023. By the time I accessed it, read it, and stored it, I burned 6 minutes of my time, which I will never get back. If I were to do that for all 1732 items, it would take me:

(6 minutes) x (1732) = 10,392 minutes
= 173.2 hours
= 7.22 days (without eating or sleeping).

So, I am wondering how much county employee manpower/time it took to assemble all Terry's personal private confidential phone information for **Cory Vaillancourt**.

After the last couple of emails between me and **Joey Webb, Jr.** CGCIO, I will follow them with the entire 1732 lines of items **Joey Webb, Jr.** CGCIO supplied to **Cory Vaillancourt** and me.

See my public comment at yesterday's county commission meeting - My Public Comment at the 6/19/23 County Commission Meeting, re: Joey Webb, Jr., CGCIO, and his refusal to provide Public Information. 6/20/2023...

So, get ready for yet another Public Comment at the next county commission meeting. Ensley cancelled the July 3 meeting, presumably due to everyone is going to be at the Justice Center, attending Terry Ramey's court case,

23cr325887. Cory Vaillancourt charged with SIMPLE ASSAULT. "... willfully did assault TERRY RAMEY by SCREAMING WHILE PUTING HIS PHONE IN MR. RAMEY'S FACE, FOLLOWING HIM SCREAMING WITH SPIT HITTING MR. RAMEY'S FACE AND HANDS." 6/5/2023. 6/7/2023...

As you might recall, in my piece on May 16, UPDATE! Email Dialog with Joey Webb, CGCIO. Request for Public Information - Ramey Cell Phone data sent to Cory Vaillancourt. 5/16/2023...

I created a possible scenario:

Possible Scenario.

Let's suppose that Joey Webb, CGCIO connected to Terry Ramey's cell phone to a county computer. Then, Joey Webb, CGCIO used the "send" feature on Terry Ramey's phone to transmit vital information to the county computer. Once on the county computer, the following people spent God Knows how much time going through the redaction process -

- **Joey Webb, CGCIO**
- **Frank Queen**
- **Bryant Morehead**

Once this priceless set of data was complete, Joey Webb, CGCIO then closed it up in a file, ready to package up for Cory Vaillancourt.

But then, Joey Webb, CGCIO "forgot" to remove the original "send" data from this glob of data, and sent Cory Vaillancourt both the redacted data + the original (unredacted) data. Cory Vaillancourt must have had a field day!

If this possible scenario holds out, I see only two paths.

- **If Joey Webb, CGCIO intentionally included the "send" file, providing access of Terry Ramey's vital personal and private information to Cory Vaillancourt, then Joey Webb, CGCIO could possibly be looking at spending some time in an 8 x 10 foot room at a Federal Institution, or**
- **If Joey Webb, CGCIO provided access of Terry Ramey's vital personal and private information to Cory Vaillancourt through either incompetence or stupidity, then Joey Webb, CGCIO should be fired.**

This is what I plan to discuss at during the next public comment session, on July 17. Hope you do a little better with the sound system at that meeting.

I received your response to my Request for Public Information. Recall that I requested "Please send me the exact, and I mean the exact, copy(s) of the information that you sent to Cory Vaillancourt, which includes every time you sent Cory Vaillancourt information."

Now take a look at just the first screenshot you sent to me - Screenshot_20230324_122712_Messages.jpg

Now look at the attachment I am sending you, which is a printout of some of that screenshot. See the attachment - "230626 Joey Webb idiot response.pdf".

You indicate the data this was uploaded to your computer was 6/23/23, which was three (3) days ago!

This is obviously not what you sent to Cory Vaillancourt.

Your response includes approximately forty-nine (49) pages of stuff, presumably the files, screenshots, whatever, that were redacted by you, Frank Queen and Bryant Morehead. I'll be willing to bet none of these contain any information about Citi Bank or any of the other confidential material Cory Vaillancourt wrote in his hit piece in the smn tabloid. So how did he get it?

So, where are we? As far as I am concerned, I am going to present yet another Public Comment at the next County Commission meeting, going into great detail on the "Possible Scenario" as outlined below,

You decide to cough up the - "I mean the exact, copy(s) of the information that you sent to Cory Vaillancourt."

I want the files, not screenshots.
