Martha Sharpe Bradley seems to be the single person steering the boat at this point, and the only person to respond, even though this email is widely copied. It appears conclusive at this point that two things are apparent. Martha Sharpe Bradley and Jesse Fowler are:

- Perpetuating a hoax,
- Lying by Omission.

The walls are starting to close in and these two people are struggling. In the following series of emails, **Martha Sharpe Bradley** is concentrating more on keeping her [expletive deleted] out of the fire (i.e. worried about a pending Grievance to be filed against her) than responding to my request for reviewing the Rec Center video footage.

When I first received an unsolicited invitation to view Rec Center surveillance video, it was via an email from **Jesse Fowler** on 7/24/2023 at 2:21 pm. I responded with a phone call to **Jesse Fowler** at around 2:40 pm. We both agreed to meet at the Rec Center at 3:15 pm. **Jesse Fowler** arrived with **Martha Sharpe Bradley** shortly there after, at around 3:20 pm.

That is less than an hour elapsed time after his first invitation before I actually reviewed the videos.

It has been over 24 hours of stalling by **Martha Sharpe Bradley** since my initial new request to her on 7/26/2023 at 9:35 am.

Every second she burns up refusing to allow me to view the newly requested surveillance video and take pictures of the women's locker room does not look good, and is most certainly going to add to the Grievance that will inevitably be filed against her.
