## Chief Adams,

It has come to my attention that an individual(s) came to both the Haywood County Sheriff's Office and the Town of Waynesville Police Department yesterday to file an incident report on the events in the afternoon of 7/12/2023, regarding **Indecent Exposure** in the Rec Center's women's locker room. This is related to your original incident report WPD2301051 by Detective Paige M. Shell. At this point, I'm uncertain if the Sheriff's Department has jurisdiction in this matter yet. Under any circumstances, I would like to append my Request for Public Information to now include any new information supplied by this individual yesterday, whether it is appended/added to the original incident report - WPD2301051, or whether you create a new incident report for the event that happened on 7/12/2023.

I further understand that photographs of this event exist in or near the women's locker room, the afternoon of 7/12/2023 which include the alleged perpetrator, the he/him/her/she/they/them/it/whatever transgender male who invaded the women's locker room re-entered the Rec Center later in the day and freaked out two underage girls.

Currently, both Martha Sharpe Bradley and Jesse Fowler are obstructing my original request to

- View surveillance security footage of the motion detected camera positioned in the hallway which shows the entrance to the family changing room and women's locker room during the afternoon of 7/12/2023,
- Access to both the women's locker room and sauna for the purpose of my taking photographs so that I can correlate those with any that might be introduced if these new photos become available.

Please investigate what it will take for me to secure a search warrant to both view the security footage and obtain access to the women's locker room and sauna, and please provide the new/updated incident report information when available.
