WHILE AT THE MAYORAL DEBATE THIS EVENING, CANIDATES WERE DISCUSSING THINGS THEY HAVE DONE IN WAYNESVILLE THEY FELT WERE MOST ACCOMPLISHED. CANIDATE JOEY REECE BEGAN DESCRIBING HIS ACTIONS IN FROG LEVEL WHEN MAYOR GARY CALDWELL BEGAN SPEAKING OVER REECE SAYING "THATS NOT TRUE", CALDWELL STATED THIS SEVERAL TIMES, BEFORE TAKING HIS LEFT HAND AND BY USING HIS FINGERS BEGAN PUSHING THEM INTO REECE'S RIGHT ARM SAYING "DONT PICK ON ME". SHELL WAS MADE AWARE AND ARRIVED A SHORT WHILE LATER, AS REECE WAS LEAVING HE FURTHER STATED HIS DESIRE TO OBTAIN WARRRANT ON CALDWELL, BUT NEVER OFFICIALLY ASKED OR INDICATED HIS DESIRE TO MAKE A REPORT TO ANY LAW ENFORCEMENT OFFICERS AT THE DEBATE.
