**Subject:** Mark Pless/Team Waynesville = 3, **Rob Hites/Incumbents** = 0. Email Dialog with **Rob Hites**.

Citizens of the Town of Waynesville will be paying off a \$25M Loan for repairs to upgrade the Sewer System that have been so severe the State has placed moratorium on new hook-ups until the problem is resolved. Other nearby counties and municipalities received funding from the state legislature for their infrastructure problems simply because they requested help from Mark Pless.

Waynesville's sewer problems not happen yesterday, but have been lingering for years under **Rob Hites** and the current Town Council. Waynesville is not the only municipality with these problems. Canton, for example, is losing their sewer system with the close of the paper mill.

Twice, once during a Rally for Team Waynesville, immediately following the Apple Festival on 10/21/2023, at 6 pm on the Courthouse Steps, and again on a YouTube video with Team Waynesville candidates,

Mark Pless rattled off various counties and municipalities that had received infrastructure funding from the legislature, simply because they asked him for it. Waynesville did not receive funding, because no one from Waynesville asked, because no official in Waynesville likes Mark Pless.

To get to the bottom of this, I made a Request for Public Information to **Rob Hites** for the following:

"Please provide the original grant application to the state by **Rob Hites**, indicating who at the state it was sent to and when, along with the rejection notification."

Results of this Request for Public Information were unfortunately unsatisfying from **Rob Hites**.

In the final analysis -

- Mark Pless demonstrated that multiple counties and municipalities received funding from the state legislature because they simply asked him for it, and
- The only document **Rob Hites** responded with was an Application for NC DEQ (Department of Environmental Quality), Division of Water Infrastructure, North Carolina, Wastewater Treatment Plant Supplemental Funding, Submitted by: Town of Waynesville. Prepared by **McGill Associates**, 55 Broad Street, Asheville, NC 28801. Fall 2022. No rejection letter was ever produced.

This entire email dialog began on 10/26/2023, after the Rally after the Apple Festival, and ended yesterday with **Rob Hites** informing me: "That concludes the information we have on the subject.", i.e., a blow-off.

Town Council Incumbents, obviously concerned, called out chief water boy **Cory Vaillancourt** and chief water girl **Vicki Hyatt** with two articles yesterday to carry their water. See their articles respectively in the snm tabloid and the mountaineer (behind a pay wall).

It hit the fan yesterday.

Prior to being designated as "at-risk", the Town of Waynesville received a CSWRF loan of \$19,545,900 (CS370930-01) in July 2019 and supplementary loan of \$5,000,000 in July 2022. With the Town being on the verge of Distressed status, any and all grant funding will be critical to ensuring the long-term viability of Waynesville's utility enterprise fund. The Town of Waynesville is seeking \$15 million ARPA grant with the remainder SRF loan.

So, where did you ever pick up the phone and call Mark Pless? Where is the rejection letter?

You have provided nothing that counters what Mark Pless said at the Apple Festival Rally at 6 pm on the courthouse steps, nor in his video along side Team Waynesville Candidates. What say you?
